## UGC seeks to bridge skill gap with short-term industry courses

The University Grants Commission (UGC) has issued guidelines for introducing short-term industryrelevant courses in the Higher Educational Institutes (HEI) to bridge the skill gap, Deepak Kumar Srivastava, Vice Chairman, has said.

The guidelines will help formulate the premise for integrating skilling into higher education at all levels, Srivastava said at an ICAI-organised National Education Summit on Commerce & Industry in the capital. The short-term industry-relevant courses will be certificate courses. Stating that UGC is closely working with HEIs, Srivastava underscored the

need to prepare an ecosystem among accounting professionals who are equipped with multiple skills matching the requirements of the global job market.

He also said that accounting professionals have to be proficient in information technologies including newer areas like artificial intelligence. Srivastava highlighted that ICAI plays a crucial role in promoting financial transparency, accountability and good governance. He noted that India is poised to become the thirdlargest economy in the next five years. Srivastava also pointed out the strong growth in the Indian startup ecosystem in recent years.

This Summit was organised by the ICAI to shape the future of commerce education with One India One Commerce education.



## BBMP officials on radar for not paying Rs 397-cr cess to library dept

The legislature committee has demanded action against the BBMP chief commissioners responsible for not paying a total of Rs 397 crore it collected as library cess to the department concerned. The letter also reminds the assurance given by the Bengaluru development minister to ensure the dues are cleared. In a reply, the BBMP shared the names of 14 chief commissioners, from Dr S Subramanya to Gaurav Gupta, who held the top post during which period the library cess was not released to the department. The civic body has assured that the Rs 397.37 crore would be released to the library department in the next four financial years.



"A bank account has been opened in a nationalised bank. The payment would be released in four parts," the letter states.

It pointed out that factors like payment to contractors, clearing of loans and providing infrastructure to schools led to the delay in clearing library cess.

About 6% of the property tax that the BBMP collects goes to the library department as library cess and 3% is set aside as beggary cess.

## Aligarh Muslim University surrendered its minority status, Centre tells SC

The Centre on Tuesday contended before the Supreme Court that the Aligarh Muslim University surrendered its minority character when it was conferred with university status under the 1920 AMU Act.

A seven-judge bench led by Chief Justice of India D Y Chandrachud and comprising Justices Sanjiv Khanna, Surya Kant, J B Pardiwala, Dipankar Datta, Manoj Misra and Satish Chandra Sharma decided to consider the contention while hearing pleas in connection with the minority status of AMU.

Solicitor General Tushar Mehta referred to the predominantly national and non-minority character of the university from its very inception. not amount to the surrender of minority status. We have to independently see whether, by the Aligarh Muslim University Act 1920, a denominational character of AMU was lost," the bench asked.

Mehta cited correspondence between the British government and AMU regarding its minority status and the debates in Parliament where a bill was introduced, and it was on surrendering denominational character.

Referring to the apex court judgment in the Azeez Basha case, Mehta said it says that after the Act came into effect, it cannot claim minority status.

Senior advocate Rajeev Dhavan, representing the AMU, said the word surrender is only used in respect of property (not minority status).

The bench asked if the Aligarh Muslim University Act 1920 had the consequence of abrogating its status as a denominational institution governed by a religious minority.

Mehta said there were institutions during British rule which had reputation and granted degrees, except they were not under the British crown, like the Scottish College, Roorkee College, etc. He said there were several institutions that chose not to align with the British. He said that when an institution agrees to the terms and conditions of the government and chooses to be dissolved, its earlier status is relinquished.

"What are the indicia to indicate that when AMU was conferred with university status, it surrendered its minority status? That mere fact that it is given a university (status) does stitution may set up a purely secular form of educational institution, an architecture college, or a medical college. Mehta said he has no quarrel with this observation.

The bench said the court would examine whether the institution acquired minority status as of January 26, 1950.

Mehta also claimed the AMU founders were loyal to the British. "It does not deprive it of its minority character. The fact that they were in alignment with the view of then-imperial power does not make it any less of an institution founded by a minority. Founded by a minority does not mean that you have to be in opposition to the government. Today, you have minority institutions that are on the side of the government on important issues, that does not change its minority character...," the bench said.

#### 'Scrap seat-leaving bond in PG medical education'

Students facing stress, seats no longer going waste, says NMC

Rollowing complaints of mental stress from post-graduate students, the National Medical Commission has asked states and Union Territories to do away with the practice of the "seat-leaving bond" in PG medical colleges, which ask students to pay hefty fees if theyleave midway for any reason including ragging, work stress or toxic environment.

The NMC says such bonds cause mental harassment to students and their families, triggering "alarming levels of stress, anxiety and depression" and the "unlucky one may commit suicide in such mental health condition".

With a 117% jump in the number of PG medical seats in the last 10 years, the issue of a seat going waste – main reason for states to introduce such a bond - was not of much importance, Aruna Vanikar, president of the Under Graduate Medical Board at NMC wrote in her letter to the states.



According to the Health Ministry data, the number of PG seats in medical streams rose to 67,802 by August 2023 from 31,185 before 2014.

For years, these bonds had been a common practice for post graduate medical students as states devised penal-

ty rules if a student wanted to leave courses midway.

The NMC released seven specific case studies of students, some of whom had to pay a penalty of Rs 30 lakh, forcing at least one family to sell its land and another to write to the Prime Minister. One student expressed suicidal thoughts.

The cases cited by the regulator are from Madhya Pradesh, Maharashtra, Uttar Pradesh and Telangana. The examples range from a student who has to work for a "gruelling 36-hour duty shift without rest" to "ill-treatment by seniors" and "toxic work environment".

With ragging and hostile work place being some of the key factors forcing students to contemplate a change of the institution in the first place, the NMC's anti-ragging panel discussed the issues on January 9 following which Vanikar recommended to the states to do away with such a practice.

## KSEAB prepares database of eligible evaluators

#### Move helps to avoid delay in announcement of PU results

Rollowing the state government's decision to conduct three board examinations from the current academic year, the Karnataka School Examination and Assessment Board (KSEAB) has prepared a database of eligible evaluators to avoid inconveniences during the evaluation and to avoid delay in the announcement of results.

The Board had asked all

the eligible teachers to register voluntarily and so far as many as 51,000 teachers have registered. According to the teachers data available with the Department of Pre-University Education, 61,000 teachers are working with various pre-university colleges.

"There are over 4,866 government, aided and private colleges in the state and as many as 61,618 lecturers are serving in these colleges. So far, 51,479 lecturers have registered and the remaining 10,139 are expected to register in a week or so," said a senior official of the Board.

The official said that the Board has decided to announce the results of the II PU examination-1, within a week. "A total of 7 lakh students have registered for the examination-1 and we need to conduct the examination-2 within a month of the announcement of results of examination-1," he said.

As explained by officials, considering the number of evaluators remaining absent for the evaluation work every year, the Board has decided to prepare a database of all eligible teachers. "All these years, we were utilising the services of around 35,000 lecturers. But when some lecturers skip evaluation work, the entire process used to get delayed. To avoid such delays, we have directed all eligible lecturers to register," the official added.

According to KSEAB officials, the highest number of evaluators is needed for the languages and next comes the commerce stream. The II PU examination 1 will be held between March 1 and 22.

## 5G mobile rates to rise as operators look to monetise tech

#### **Janaki Krishnan** Mumbai

Mobile telecom services users who have enjoyed unlimited 5G data at no extra cost can expect stiffer bills as tariffs are set to head north soon, with Reliance Jio expected to raise rates as it seeks to monetise 5G services.

Tariffs were stable last year, with the top players Bharti Airtel and Reliance Jio focussed on their 5G roll-out targets. However, this is likely to change with RJio reporting flat ₹182 ARPU (average revenue per user) in the September and December quarter.

which makes a case for a tariff hike. The exact quantum of hike will depend on the traction for 5G and the number of users.

RJio added 11 million subscribers in the third quarter and data usage at 27.3 GB per SIM per month rose 2.4 per cent sequentially. Its revenue per GB fell 2.3 per cent sequentially, and 16 per cent on year to  $\gtrless6.7$ .

#### **FLAT ARPU**

Reliance Jio currently offers unlimited data at no extra cost to 5G users. This has limited the growth of the ARPU, as was pointed out by the management at the Q3 results briefing. If the ARPU has to rise, RJio has to introduce dedicated 5G data plans, and this would mean an increase in tariffs that may happen sooner than expected.

"We believe the focus will now shift to monetisation, with a tariff hike likely in the next few months," said Kotak Institutional Equities. RJio said it has completed the roll-out of 5G services. JioAirfiber and its offerings for the enterprise segments have seen traction,

#### NOT A GAME CHANGER

After hikes in 2019 and 2021, telecom rates have been stable for the most part as operators have been concentrating on expanding their subscriber base. 5G launch was supposed to be a game changer in terms of Internet speeds and its use in a number of segments. However, the 5G uptake has been poor, BNP Paribas Securities said.

Operators have rolled out 5G services at existing plans and it is time that monetisation starts with separate data plans that may come bundled with other content.

## How AI & Gen AI are changing the future of India's BPM biz

#### Cos today are even impacting business performance of global corporations

ohit Kapoor, vice chairman & CEO of EXL, one of India's biggest business process management (BPM) companies, says it used to take one of their insurance clients six to 12 months to launch a new product. It involved creating the IT system, putting the policy in place, defining the underwriting standards, testing those standards, going through compliance checks, pricing checks, and finally the rolling out. "But now, with the use of automation, the use of AI and Gen AI, we can actually launch a new product for them in six weeks. And in six weeks, they have the same rigour on compliance, they have actually better testing of their product, because it's not sample testing, but is 100% testing of the code," he says.

What's more, as the insurance company's end-customer preferences change, they can adapt to that very quickly, Kapoor says. This is enabling EXL to powerfully influence their client's growth. Technology, Kapoor says, is enabling them to bring together data from disparate data sources, and tie them all together, analyse them, it's enabling the ability to test and control changes quickly, and it is creating the ability to personalise products and services.

Over the past 25 years, India has built the strongest BPM base in the world, taking on more and more of the processes of the world's largest companies. And now, AI and Gen AI are enabling them to more substan-

#### SOME JOBS GETTING AUTOMATED, BUT MANY NEW ONES ARE EMERGING

In the medium term of 2 to 3 years, 20% of current job roles in BPM may get automated. But the good news is, there will be 40% of new, higher-value jobs, given all the capabilities that new technologies bring. Transaction processing will get automated, but the ability to do exceptional handling with empathy, that will bring new

roles. Roles like what chief customer officers do, which traditionally was internally done, are increasingly being given to BPM partners. K S Viswanathan | vp -NOUSTRY INITIATIVES, NASSCOM

The problem statement we're struggling with right now is twofold. How do we skill our existing teams onto the new AI? A lot of it currently is happening organically. All of us are now thinking about what is that outsidein training we need to provide to bring employees up to speed on the opportunities. The other thing is. there are new fields coming in, like prompt engineering, which will create a lot of jobs. We've got to train people to be able to do that kind of work.

Harita Gupta CHAIR - NASSCOM BPM COUNCIL, AND SVP & APAC HEAD, SUTHERLAND

The jobs that will be automated are simple data entry, simple query resolution, roles that involve putting together a lot of information, collating standard reports. But there

will be new roles, in data engineering, in prompt engineering, jobs where you use LLMs and apply them in the core operating processes. The personalisation strategies that AI and Gen AI enable will require more and more people. Lot more new roles will be created than what will be eliminated. Rohit Kapoor | VICE CHAIRMAN & CED, EXL

tially influence the operations of their customers.

KS Viswanathan, VP of industry initiatives at Nasscom, says AI is impacting four 'Ps' - productivity, performance, prediction, and personalisation. Gen Al proofs-of-concepts (PoCs), he says, have clearly demonstrated significant improvement in productivity (like in code generation, content summarisation). It is improving business performance - by enabling use of data to impact topline, bottomline and customer satisfaction. It is enabling predictions through data, which is

crucial in today's world of uncertainty And it is enabling companies to understand customers in ways that were unimaginable till recently, allowing for personalisation of products. All of these, Viswanathan says, are further strengthening the BPM industry's partnerships with global corporations.

#### **Unparalleled** capabilities

Harita Gupta, SVP & Apac head at BPM company Sutherland, and chair of the Nasscom BPM Council, says Gen AI is enabling the transformation of chatbots into conversational AI that is providing customers a substantially better experience. "A chatbot is a static bot that chats with you. It does not have much memory, it does not have much history of what happened on your earlier chats, it is not able to correlate (data from different sources), it is not even able to do a good job of curating knowledge. But now, when you add AI to the bots, we've got this completely new field called conversational AI," she says. It can have a chat with you exactly like a human, correlating data from many sources, and previous chats. Gupta says it is

even enabling Indian BPM staff to service Spanish-speaking customers write in English, and it instantly translates it to Spanish. "We deliver 15 global languages sitting out of India with Indian workforce," she says. Right now it's happening on chat, but voice is just a matter of time

Conversational AI, Gupta says, is particularly useful when, for instance, e-commerce sites see a surge in traffic on special days, when it would be impossible for human agents to manage it.

Gen AI's knowledge management capabilities, Gupta says, is also a huge benefit for human agents, enabling them to service customers far better. "And once the call is over with a client, or the back office process is complete, there's a lot of documentation the consultant or the agent needs to do. Imagine if I could automate that through my AI tool! Just solving that business challenge will be a big

game changer," she says. Kapoor says they've built a product that can predict, based on a number of attributes, who is likely to become a high networth individual, so that a customer using the product can get to them early, serve them,

and build their loyalty, before competitors get to them.

He says it's possible for the BPM industry to do such things because their knowledge of each industry is phenomenal. "In insurance, we work with about 200 large companies. So, our domain knowledge of insurance is far superior today as compared to any single insurance company. Also, because we handle the core operating processes of our clients, we get to see the data flows. All of this gives us tremendous capability to do largescale, enterprise-wide changes for our clients," he says.

## How to make the most of a short exercise

A few tips on having an effective workout – even if you only have a few minutes to spare

hen it comes to exercise, there's a difference between what's ideal and what's possible. So, while in a perfect world, you'll manage to devote an hour a day to your fitness, in the real world, it can be difficult.

But that is ok, say experts; even short bursts of exercise can have health benefits. Barb Puzanovova, a Tennessee, US-based personal trainer, said, "You can see increased mobility, better sleep, better strength and increased bone density with shorter, simpler workouts."

Here are some tips to get you started:

#### Focus on strength training

Jessie Mundell, a fitness trainer in Ontario, Canada, said she prioritises resistance training when time is short. "Strength training is effective at elevating the heart rate, bringing it down a bit and then back up again," she said.

A 2021 analysis of 45 studies on resistance circuit-based training found that it improved not only muscle mass and strength but also several important markers

of cardio-respiratory fitness, especially among people who were new to it.

#### Hit the major movements


"Working through movements you do in everyday life gives you better spatial awareness, coordination and overall strength to reduce your chances of getting hurt," said Joe Holder, a personal trainer in New York. Here are a few simple moves:

#### Squatting

Squatexercises involve bending at the hips, knees and ankles and can strengthen your quadriceps, glutes and lots of small stabilising muscles. They help you with an essential daily activity: Sitting down and standing back up. Examples include traditional squats, widerstance sumo squats and lunges.

#### Hinges

With this movement, you keep your back straight while hinging at the hips, whether in a deadlift, glute bridge or kettlebell swing. The focus here is on the glutes and hamstrings, but your back and core get some attention, too. These exercises help you safely bend forward, lift

heavy things and put them back down.

#### Pushing

These include pushups,

chest presses, overhead presses and push presses. Depending on whether you're pushing vertically or horizontally, push movements can strengthen your chest, shoulders, triceps and back.

#### Pulling

These movements, including pull-ups and chin-ups, are excellent for supporting your posture. They can help strengthen your back, your rotator cuffs and even your grip. If your goal is to move through the day with less back pain, Holder said, pulling exercises are key.

#### Core

Your best bet is to have a menu of core exercises and mix it up — planks and crunches, sure, but also consider wood chops, bird dogs, farmer's carries and beast pose. "To build a stronger core, you need to challenge your abdominal muscles with a variety of movements," Mundell said.

#### Stick to supersets

Supersets — when you move quickly from one exercise to another without taking a break — make a short workout efficient and challenging. Select one exercise from each category above and group them into three pairs. For example: Squats and pushups; glute bridges and single-arm rows; wood chops and bird dogs, etc.

Do each exercise for 45 seconds to one minute, or for eight to 12 reps. Do the second exercise in the superset immediately after the first to keep your heart rate elevated. Then take a short break before repeating the superset or proceeding to the next one. Try to complete at least two rounds of each superset.

#### Warm up and stretch down

When you're already pressed for time, warm-ups may seem like a luxury, but consider three to five minutes of jogging or marching to raise your heart rate, shoulder and hip circles to warm up your joints, and body-weight squats and lunges to get ready for a workout.

But if you still can't manage the time, Mundell suggested, "just get into the workout right away and use your first round of the supersetata lighter weight".

Ditto with a stretch post exercise. If you can, go ahead. "But you can also skip it, and just let it be good enough for that day," she added.

#### FIT BIT

#### UTTANA PRISTHASANA VARIATION

#### (EXTENDED LIZARD TAIL)

In Sanskrit, 'utthan' means stretch out, 'pristha' means back of the body, and 'asana' means pose. It is a preparatory pose for advanced hip-opening postures. It activates the Svadhisthana, the chakra associated with creativity, confidence, and survival instinct.

#### STEPS

- Start in Adho Mukha Svanasana (Downward Dog Pose).
- Place your right foot close to the outer edge of the right forearm, and your foot, heel, and toe should be towards the edge of the yoga mat.
- Bend your hips forward and gently walk towards your hands until you come down onto your forearms. Place your forearms on the floor, keeping your chest open.
- Make sure that your left leg, from the knee to the toes, is placed behind you.
- Stretch your spine and bring your shoulder blades forward.
- Keep your right knee near the middle line and look straight.
- Maintain the pose for around 30 to 60 seconds. Then release.
- Repeat the same process with the other leg.
- You can also place your leg in between your hands instead of on the side of your forearms.

#### LIMITATIONS

Practise it on an empty stomach in the morning. You can also do it in the evening .

At least have a gap of 3-5 hours between your practise and meal.

People recovering from surgeries, suffering from sciatica or back maladies, or having injuries to the hips, knees, ankles, shoulders, elbows, wrists, neck, rib cage, and spine should avoid this.

#### BENEFITS

- Stretches the muscles of the legs, gluteus, hip flexors, psoas, back muscles, shoulders, and arms.
- Helps with the alignment of the body and increases its stability.
- Opens your chest, shoulders, hip flexors, groins, and hamstrings.
- Massages the muscles of the knee and elbow joints, as well as your internal organs.
- Strengthens your inner thigh muscles and quadriceps.
- This asana is very effective for your body, mind, and soul.
- Enables you to effortlessly perform other advanced asanas.
  - Helps with the better functioning of the lungs.
  - Improves the flexibility of the spine and hips.


## GST rationalisation, tax-break on annuity top Budget wish list of life insurers

Rationalisation of the Good and Services Tax (GST) and tax-break on annuity top the wish list of life insurance industry ahead of Union Budget 2024-25.

GST rate rationalisation on term policies from the current rate of 18 per cent may also help make life insurance more affordable for the masses, who are keen on buying protection-oriented products, according to Sumit Rai, MD and CEO, Edelweiss Tokio Life Insurance.

"With the experience in the last 2-3 years, it can be viewed as a social necessity to reduce the GST burden, making the category more aftold Rai fordable," businessline. "There is a vast ageing population, which underlines the burgeoning pension and annuity market in India. A tax break on annuity could, therefore, be a game changer," Rai added. Currently, annuity is completely taxed in the hands of the customer, which spoils

## Byju's reports losses of ₹8,245 crore for FY22, consolidated revenues at ₹5,298 cr

**RED FLAG.** Cloud hangs over ability of group to continue as a going concern, says auditor

Embattled edtech major Byju's filed its FY22 financials with the Ministry of Corporate Affairs, and has said that losses ballooned to ₹8,245 crore in FY22 from ₹4,564 crore in FY21.

businessline had earlier reported that the FY22 financials tabled during the company's annual general meeting in December 2023 showed that consolidated revenue from operations stood at around ₹5,000 crore, with losses crossing ₹8,200 crore.

Earlier in November 2023, the company revealed that its standalone revenue from core business rose to ₹3,569 crore, while it recorded an EBITDA loss of ₹2,253 crore. Byju's consolidated revenue jumped 118 per cent to ₹5,298 crore in FY22 (₹2,428 crore).

In the FY22 financials, Byju's auditor cautioned that a material uncertainty exists due to its large losses and a \$1.2-billion loan that may cast significant doubt on the group's ability to continue as a going concern.

#### AUDITOR'S CONCERN

The auditor said, "However, as explained in the Note, the management has undertaken various measures to improve its operating financial condition, is also in the process of securing necessary funding arrangements and exploring sale of assets as needed, and hence is confident regarding the future viability of the group."

In November 2023, tech investor Prosus marked down the value of its stake in Byju's, resulting in a company valuation of less than \$3 billion, representing an 86 per cent decline from the previous valuation of \$22 billion.

#### Tax-GDP ratio at 15-yr high during FY23

#### Tax buoyancy falls compared to FY22

The share of direct taxes in gross domestic product (GDP) rose to a 15-year high of 6.11 per cent during 2022-23 (FY23), but their buoyancy fell to 1.18 from 2.52 in the previous year, according to official data released on Tuesday.

This means that while the tax-to-GDP ratio registered a record high during FY23 since 2008-09, the economic growth at current prices could not result in as high a rise in direct tax collections during the year as witnessed during 2021-22 (FY22).

However, direct tax collections rose higher than economic growth during FY23. While nominal GDP rose 15.11 per cent during the year, direct tax collections rose 17.79 per cent, revealed data released by the Central Board of Direct Taxes.


A year earlier, nominal GDP grew by 19,51 per cent, but direct tax collections rose by 49,12 per cent. Thus, direct taxes grew at a rate which was 2.52 times the GDP growth rate in nominal terms.

Direct taxes rose by 160.52 per cent to ₹16.64 trillion during the concluding year of the Narendra Modi government 2.0 (2022-23) over ₹6.38 trillion during the last year of the Manmohan Singh government 2.0 (2013-14).

On the other hand, gross direct tax collections registered an increase of more than 173 per cent at ₹19.72 trillion during FY23 over ₹7.22 trillion during 2013-14 (FY14).

Direct taxes contributed 54.62 per cent to the overall tax kitty during FY23 against 52.27 per cent in the previous year. However, this share was higher at 56.32 per cent during FY14. The decrease in contribution to direct tax col-





lections in the overall tax kitty could be attributed to robust goods and services tax (GST) collections during FY'23. However, subdued excise duty collections came in the way of the indirect taxes' share remaining less than half of the total tax kitty.

Central GST, the main segment of GST collections on Union government books, rose 21.53 per cent at ₹7.18 trillion, while Union excise duty mop-up declined 18.37 per cent at ₹3.19 trillion during FY23 year-on-year.

Corporation tax at ₹8.26 trillion was slightly less than ₹8.33 trillion from personal income tax during FY23.

The cost of collections of direct taxes declined to 0.51 per cent. the lowest since 2000-01, the data showed. This implies that the administrative machinery to collect direct taxes has become more efficient over the years.

## Axis Bank net rises to ₹6K cr

#### Profit up despite margin impact from higher cost of funds

Piender Axis Bank on Tuesday reported a 4 per cent year-on-year (Y-o-Y) increase in its net profit to ₹6,071 crore for the December quarter of 2023-24, even as the rise in the cost of funds impacted margins.

The total income swelled to ₹33,516 crore in the third quarter of the current financial year, compared to ₹26,798 crore in the year-ago period, Axis Bank said in a regulatory filing .These numbers are not exactly comparable as the acquisition of Citibank's retail business came into effect from March 1, 2023.

The net interest income reported 9 per cent growth to ₹12,532 crore, while other incomes were up 22 per cent to ₹5,555 crore.

## Equity and money markets in the US remain polarised, says Chris Wood

Equity and money markets in the United States (US) remain polarised and are betting on two different outcomes in the months ahead, wrote Christopher Wood, global head of equity strategy at Jefferies in his latest note to investors, GREED & fear. While the US stock market, he wrote, is priced for an idealised soft landing of the economy, the money markets are priced for a degree of monetary easing, which only seems likely in the event of a recession.

"The Fed funds futures are now discounting 144 basis points (bp) of rate cuts this year, though down from 168bp anticipated on January 12. GREED & fear's base case remains that a downturn is coming as signalled by the collapse in US M2 growth," he said.

Another key development in the US that the global equity markets will eye over the next few months is how the political landscape shapes up ahead of the presidential elections. Donald Trump's victory by a 30-point margin in Iowa recently, Wood believes, is the latest evidence that the more indictments are levelled against him (Trump), the more support for him grows.


"A recent poll also found that Trump was leading Biden in Michigan, a key battleground state, by eight percentage points. The



major problem for the 45th American President is that the election is not being held now. But if a downturn does hit the US in coming months, causing a stock market selloff with it, it would set up the stock market for a rally in anticipation of pro-growth Trumpian policies," Wood said.

#### **Bondyields**

Back home, the rising bond yield in the US that hit 4.16 per cent recently, has put equity market investors in a spot of bother. Foreign institutional investors (FIIs), analysts said, have taken money out of the emerging markets, with Indian markets seeing an FII sell-off to the tune of over ₹20,500 crore in the last few trading sessions alone.



FII selling due to external factors, analysts say, has always been an opportunity to buy, and this time is no different. "An important trend in the market that has implications for retail investors is the revival of the tug of war between FIIs and domestic institutional investors (DIIs). FPIs have sold equity massively during the last few days. This is partly in response to the rising bond yields in the US, where the 10-year yield has risen to 4.16 per cent, and partly due to the high valuation in the Indian stock market," said V K Vijavakumar, Chief Investment Strategist at Geojit Financial Services.

#### Market strategy

The Indian economy, according to

analysts at BNP Paribas India, remains on a strong fundamental footing with inflation-related concerns and the worries related to the outcome of general elections now easing a bit. However, they do caution against the high valuations.

The other concern, according to Kunal Vora, Head of India Equity Research at BNP Paribas India, is that the (economic) recovery has not been broad-based, with massconsumption categories still under pressure. A renewed interest in China and an increase in LTCG tax on equities as the government looks to mobilise resources to drive mass consumption are also potential risks.

"We expect Indian equities to trade at a premium to their historical valuations. In our base case, we expect Nifty 50 to trade at 20.2x December 2024 next 12-months (NTM) P/E. We arrive at a Nifty Index target of 23,500 in our base case by December 2024," he said.

Among sectors, Vora prefers affluent consumption over mass; and prefers private banks, given their strong fundamentals and reasonable valuations.

"We expect IT services growth to recover and telcos to raise tariffs. We would avoid staples and pharma for growth challenges. We expect autos to consolidate after a strong 2023," he added.

## On turners, India will have to tackle a transition query

With no Kohli for the first two Tests, focus is on a batting unit that is inexperienced in facing a promising bowling attack on pitches aiding spin



HYDERABAD: On England's last Test tour of India in 2021, Virat Kohli, Cheteshwar Pujara and Ajinkya Rahane constituted the middle-order that took them on. With Pujara and Rahane eased out and Kohli unavailable for the first two Tests. India suddenly find themselves grappling with the transition question. Kohli has played 113 Tests, Pujara 103 and Rahane 85. It's an issue Indian cricket's decision-makers have feared for some time now - how it will be for India after their long-time No.4?

It happened once, when Kohli missed three Tests in Australia in 2020 with the team 0-1 down after being skittled for 36. India then could fall back on Rahane and Pujara. The two shouldered the task of guiding the young players, scripting a win against all odds. This time, even if one of them is recalled as Kohli's replacement, it will be temporary. The lack of experience in the batting line-up sticks out as India go into the first Test starting here on Thursday.

Skipper Rohit Sharma is India's most seasoned batter with 54 Tests, but at 36 he is also looking at maximum the current World Test Championship cycle. KL Rahul, 31, is likely to bat at Kohli's spot in the first Test starting on Thursday, but after 49 Tests he averages a modest 33.60. For a smooth transition, it puts the focus on Shubman Gill, Yashasvi Jaiswal and Shreyas lyer.

Gill, 24, has played 20 Tests. He is seen as the long-term heir to Kohli's spot as the batting lynchpin but hasn't lived up to the promise he showed in Australia in his debut series (2020-21). His overall average is 30.59. Against England he averages 17.50 in five Tests, four of them at home. Yashasvi Jaiswal has played four Tests, and none at home. Both have played domestic first-class cricket but conditions in the Tests will be far more challenging.



The 29-year-old Iyer has played 12 Tests, seven at home. He did well against New Zealand (50.50 avg) and Sri Lanka (62), but struggled against the world class Australian bowling last year. In four innings, his top score was 26 for an average of 10.50. He has the temperament though, having produced matchwinning innings in Bangladesh in the 2022-23 series.

The first two Tests will indicate how things will be post-Kohli. Coach Rahul Dravid said it will be a big opportunity for someone else to step up.

"Any team will miss the quality of a player like Virat. He has been phenomenal, his record speaks for itself. It just presents an opportunity to somebody else to step up and put in some performances, show what they have got," he said at the pre-series press conference.

Dravid said starting this week, the next 18 months presents the players a perfect chance to establish their credentials. "There are some good, young, exciting guys there. I won't call them all youngsters, but even people like Iyer who haven't probably played a lot of Test cricket have been in and around the group a lot. So yeah, we think they're ready. It's a good opportunity for them over the course of the next five games to set some good markers, set some good standards.

Note: Yashasvi Jaiswal yet to play a Test in India

"There is a lot of Test cricket for us over the next 12 to 18 months. We've got five Tests here, and more in India before Australia and then England again. It presents a really good opportunity for some of these players, having had some experience and taste of international cricket, to take the next few steps. Even if they haven't played in India per se, there's a lot of other exposure that they have got at various levels in these kinds of conditions. So, I don't think it should be much of an issue."

There's extra scrutiny on Gill. He has been in great touch in the white-ball format but hasn't translated it in Tests. Since moving down to No.3 in the West Indies, he has only managed 103 runs in six innings.

"Gill is a fine player. Starting out the journey as a cricketer, sometimes we forget that it takes a little bit of time at times. Some guys have success instantly. Actually, he is one of those guys who has done really well in his early days, especially in Australia," Dravid said.

He said Gill's average must be seen in the context of the team playing most of the recent games in challenging batting conditions, be it turning tracks or seam-friendly. "To be fair, to him and a lot of

the other guys coming through, they have played on pretty challenging wickets, whether in India or overseas. It's been some challenging matches over the last two, three years. It's quite hard at times for some of these guys, but he's doing all the right things. He's working really hard. He is putting in the time, putting in the effort. In the last season he has got a couple of nice hundreds for us, one in Bangladesh, and one in Ahmedabad against Australia. I think he is on the right track. Just sort of hoping that in the course of this series, he has some big performances."

India have concerns over the crucial wicketkeeper-batter's spot as well.

Dravid announced that KL Rahul, who kept wicket in the two Tests in South Africa, won't keep and that the team will pick a specialist 'keeper between KS Bharat and the uncapped Dhruv Jurel. Bharat, 30, has played five Tests while Jurel, 23, is a greenhorn with only 15 first-class games under his belt. Bharat looks the favourite but will be under pressure after a below-par showing in the last home series against Australia.

India had a minor injury scare at the nets session on Tuesday afternoon after Iyer and Rahul took blows while batting. Rahul continued to bat while Iyer resumed after applying ice on the forearm for some time.

WHEN Manchester United used to be good, there was this fear factor about them, especially at Old Trafford. It was said that teams lost matches while standing inside the tunnel before kick-off.

Facing India in a Test in India can be a bit like that. Especially if you hope to draw or win a series. The last visiting team to do that was England in the winter of 2012. Some, like Australia, have lost thrice while South Africa, West Indies, England, Bangladesh and Sri Lanka have lost the two times they have played here. Afghanistan's lone Test in India didn't enter a third day. Playing this Indian side in their own backvard is to willingly go inside a washing machine. It can be dizzving. confusing and chaotic.

In some of the other countries, matches can be played in slow motion. Here, that's not always possible. There is a tendency for matches to speed up and once the fast-forward button is pressed, visiting teams hurtle towards a loss. The India vs Australia Test in Delhi in 2023 was a case in point. The tourists were well placed at 2/85 after 18.5 overs. Less than 15 overs later, they were bowled out for 113 as they had lost 8/28 in a little over 70 deliveries. "They are really, really good bowlers, especially in these conditions," Pat Cummins had said after the game.

"I thought they bowled really well. It's not easy out there." Cummins ouite accurately summed up the chore of playing the hosts' bowling in these conditions. When you are facing R Ashwin and Ravindra Jadeja - two all-time greats in this format - it's a bit like getting treated by two dentists in a single day. One itself can be a bit too much. Imagine two. An artist and a craftsman working the angles, making geometry their friend. Ball after ball. Hour after hour. Session after session. Batters imagine things and they start playing the man

rather than just the ball. The numbers back this up. As a pair, Jadeia and Ashwin have played 39 Tests at home. In these games, they have returned figures of 422 for 8665 at an average of 20.5 while striking at least once every eight overs. You extrapolate that over a day's play and their long unbeaten record makes sense teams, on average, get bowled out for 205 in 80 overs.

English pacer, Mark Wood. was being honest in his assessment when he called this series. 'a free hit' of sorts because the hosts are expected to win. "We know the challenge (of coming) here," he said on Tuesday. "India very rarely loses at home. I think it's almost like a free hit for us where we can come in here and give it a good go." Imagine that. This is England, a side high on vibes at the moment and even they were forced to take into consideration the hosts' absurd record. "In general, they have got all bases covered." said Wood.

their record at home. The two Rs. Ashwin and Jadeia, are two future hall of famers. But what has helped them is the fastbowling carousel in the shape of Umesh Yaday, Mohammed Shami and Ishant Sharma, In that same period, Yaday (83 wickets in 27 matches while averaging 25.6 and striking every 49 balls), Shami (76 in 21; 22.1 and 42.6) and Sharma (49 in 24; 30.2 and 67.1) were the perfect foil for the two spinners. Ashwin and Jadeia may have invariably picked up wickets in every Test but the sheer dominance could not have been achieved without the pacers quietly hitting the stumps or winning lbw decisions. Nowhere else was this more

prominent than in the 2019 series against South Africa. Kagiso Rabada, Vernon Philander and Anrich Nortie were toothless, Meanwhile, Shami (average of 14.7) and Yaday (12.18) picked up 24 wickets across the three Tests. On wickets where Ashwin and Jadeja found a lot That's the other thing about of joy, Shami even picked up a

five-wicket in Kolkata. After the match, Rohit Sharma had said about Shami, "Shami, we've seen him in these conditions, not just today but previously as well\_I still remember our debut together in Kolkata. where the pitch kind of ... I wouldn't say (it was) like this but on day four, on day five, it was slightly lower and slower. and he knows how to bowl on those pitches." The match Rohit was referring to was the nine Shami picked up against West Indies in 2013. It saw him castling batters six times. It's something the Indian bowlers are champions of in their own turf - breaching the defences and getting them bowled. In fact, the five Indian bowlers mentioned in this piece have had 168 bowled dismissals since the beginning of 2013. Nowhere else is it that high. So, the key has always been hitting the top of off, finding late inward movement and skidding off the surface (for pacers).

This combination has contributed to one of the longest unbeaten records in all of competitive cricket. If England are to have any chances of escaping it, they will have to guard their stumps.

#### Rahul specialist batter, Dhruv or Bharat to take keeper's slot

A GENTEEL late winter, early afternoon sun was beating down at the Raiiv Gandhi International Stadium on Tuesday. The strip to be used for the Test wasn't covered (an indication of the strength of the sun). India were being put through their paces on the field, with both Rohit Sharma and Rahul Dravid overlooking proceedings. Even if it was an optional training session two days out from the beginning of the series, Jasprit Bumrah was the lone absentee.

Looking on from the outside. one big potential surprise was easy to miss. The hosts' slip catching practice. Shreyas Iver. Yashasvi Jaiswal, KL Rahul and Shubman Gill were the designated catchers but the man with the gloves was Dhruy Jurel Jurel, called up for the first-time. was at ease and pulled off several acrobatic saves. The 23year-old UP lad, who did feature for India A against England Lions (he had made a 50) less than two weeks ago, is a late bolter and is now well in with a chance of making a debut at the first time of asking. Saving that, KS Bharat, the current incumbent in home conditions, did have an extended net session with the bat in the practice facility near the stadium's entrance. Skipper Sharma, who was batting in the next net, also had a few words of advice for Bharat at one time.

That, in essence, was the big news to emerge from the Indian camp. Coach Dravid confirmed that one of Jurel or Bharat will keep as the management have decided to play KL Rahul as a specialist batter in this series. "Rahul will not be playing as a wicketkeeper in this series." the coach said in a press conference. "Obviously Rahul did a fantas-





tic job for us in South Africa and really played a big part in us drawing that series. But considering it's five Test matches and playing in these conditions, we felt we would go with another keeping option, considering the weather, considering the conditions. So obviously it's a selection toss-up between the two other keepers that we have." While Rahul kept wickets in

South Africa, Bharat was the man behind the stumps against Australia last year. If Jurel does get the nod, he will do so on a what is likely to be a surface that will aid spin. With the caveat that a lot can change over two days, the surface had some dry spots, especially in a good length area for spinners on both sides. Interestingly, there were also some dark spots in the middle of the strip. "It looks a good one from what I've seen," Dravid said, "May spin a little bit. How quickly and how fast, I'm not sure. But might spin a little bit certainly as the game goes on." An insider this daily spoke to said there are chances of the match going into a fifth day but he didn't sound too confident.

#### Local spinners trouble Root

At one point during Joe Root's net session in the morning, he turned around and hit the stumps with his bat. Visibly annoyed, he f-bombed himself. One of the Hyderabad U-19 bowlers had induced a false stroke and the visiting batter was not pleased with himself. He was in the middle of a torrid phase where his trademark sweep shots didn't come off. One ball fizzed off the surface, beat his edge before uprooting the stumps. Another one found the edge. After the net bowlers made way James Anderson went full tilt and Root finally managed to get some momentum. Elsewhere. Ben Stokes seemed to be moving freely enough while Mark Wood bowled from a shortened run-up.

After the session, Wood said they will continue to play the brand of cricket that has won them lots of followers . "We will adapt, we have got a captain that always wants to take the game forward so it should make for an entertaining series."

#### SECOND FOUR-DAY MATCH VS ENGLAND LIONS

Amid Debate Over Bad Scheduling Of Tests, Coach Dravid Welcomes 5-Match Series But Says It Will Be Tough On India, Eng Cricketers Who Play Across Formats

#### **'PACE YOURSELF, IT'S LIKE A MARATHON'**

Hyderabad: India's last few Test matches have been truncated affairs. In recent times, a creeping disregard for the longest format of the game - as seen in the scheduling of a two-Test series in South Africa - has been widely dehated.

Speaking on the issue ahead of the five-Test series against England beginning here on Thursday, India coach Rahul Dravid spoke on the challenges of putting players on the park in such a long series, which also involves a lot of travel. However, if does gives the teams, as Dravid put It, a chance to test strengths and iron out weaknesses.

"Sometimes you're struggling for form and it's hard to come back if you fail in the early part of the Test series, But a fivematch series is like a marathon where you've got to pace yourself. So, I think it's a really good test for the two teams. The downside from my perspective is it's tough for teams like us and England, who play a lot of cricket in different formats of the game. It's a big factor how to manage the schedules of some of our (more) busy players. Then they'll have to choose a specific time as to which form of cricket they're playing," he said.

India last played a five-match series against England during the pandemic and the Tests had to be staggered due to Covid. "It's always exciting when England come (to India), because it's one of the most followed Test series in the world. It should be five good Test matches after a long time. I really hope that we hit the ground running and maybe strike a few balls early on." Dravid said.

#### 'Batters won't take a backward step'

The India coach also hoped that his players will respond to the challenge in the absence of Virat Kohli, who has pulled out

of the first two Tests for personal reasons. "Guys like Rohit have been around for a while, Jaddu (Jadeja) and Ash (Ashwin) have been around for more than a decade. Even KL (Rahul) has been around for a while. It's a good opportunity for them over the course of the next five games to set some good markers as there is a lot of Test cricket (for us) over the next 12 to 18 months. It's a good opportunity for young players to take the next step," he said.

Dravid also said India would not take a step back when it comes to confronting England's 'Bazball' style of aggressive hatting. "I don't think we are going to be ultra-attacking. We look to play what the situation demands. But by nature, if you look at our top six seven batsmen, a lot of

guys are naturally positive and look to take the game on. There'll be some different situations in which we may need to look to push the game along or bat for long periods. But I can't see any of my batsmen taking a backward step or looking to be defensive," he said.

#### 'KL Rahul won't keep wickets'

Rahul, the coach clarified, will play as a batter this series. "Rahul will not be playing as a wicketkeeper in this series. and we were clear about that in the selection itself. We have two other wicketkeepers (KS Bharat and Dhruy Jurel), Rahul did a fantastic job for us in South Africa and played a big part in helping us draw the series. But considering five Tests and playing in these conditions, the selection will be between the two other keepers we have," he said.

The Indian coach made light of England's practice in the UAE, many miles away from the match venue, but was certain they would be tough competitors. "It's been exciting to watch them play and they've had success playing like that. They've done well in Pakistan. They've won in New Zealand and had a really exciting series against Australia in the Ashes. But we know it's going to be a challenge for them in these conditions because these are conditions we know very well. We have a lot of experience in our attack. I'm looking forward to seeing how our boys respond, because I know that we will be put under pressure."

#### DRAVID'S TAKE

ON SHUBMAN GILL'S RECENT STRUGGLES IN TESTS "Shubman Gill is a fine player. Starting out the journey as a cricketer sometimes, we forget that it takes a little bit of time. Some guys have success instantly. Actually he is one of those guys who has done really well in some of his early days, especially in Australia. He is doing all the right things. He is working really hard. He is putting in the time."

#### ON TACKLING 'BAZBALL' APPROACH

"It's been exciting to watch England play and you know they've had success playing like that. They've done well in Pakistan. They've DRAVID won in New Zealand and they had a really exciting series against Australia in the Ashes. So, we have to respect that. But we know it's going to be a challenge for them in these conditions. These are conditions we know very well. We've got an experienced attack. I'm looking forward to seeing how our boys respond. I know we will be put under pressure."

#### ON KOHLI'S ABSENCE FROM THE FIRST TWO TESTS

"Any team will miss a quality player like Virat Kohli. He is a phenomenal player and his records tell everything. He is a huge boost to the side but having said that it gives an opportunity to the other players to step up and put in some good performances."

#### Bracing for some early turn?

On the nature of the pitch, Dravid said it would take spin for sure. "It's a hard one to say. We will have a look once it (the match) starts and figure it out. It looks good, but may spin a little. How quickly and how fast. I'm not sure. But it might spin certainly as the game goes on," he said when asked about the surface.

England pacer Mark Wood, on his part, said, "We've discussed the pitch. But I wouldn't say we discuss it at length or have been worried about it. We have enough self-belief in our group that we can do something special. We've got spinners, we've got seam, we've got good hatters and we've got a good recent history behind us."



## **Limits and borders**

<u>Centre must consult States before</u> decisions that impinge on their powers

itigation concerning the territorial jurisdiction of the Border Security Force (BSF) in Punjab seems to be the result of the lack of effective consultation between the central and State governments on the issue. Punjab has filed a suit against the Union government under Article 131 of the Constitution, challenging the decision to increase the operational jurisdiction of the BSF from 15 km to 50 km. The border State sees the Centre's move as a breach of federal principles and an encroachment into the law and order powers of the Punjab police. West Bengal has a similar view, and both States have got resolutions passed in their Assemblies against the expansion. In this backdrop, the Supreme Court's decision to examine the questions that arise from the expansion of the BSF's area of operations acquires significance. In October 2021, the Centre had issued a notification under the provisions of the BSF Act, standardising the area over which the BSF would have jurisdiction to operate. In Punjab, West Bengal and Assam, the distance was raised from within 15 km from the border to 50 km, while it was reduced from 80 km to 50 km in Gujarat. For Rajasthan, it was kept unchanged at 50 km. The Union government said in a reply in the Rajya Sabha in December 2021 that the extension of the BSF's jurisdiction will help it discharge its border patrol duty more effectively. While the Union government may have valid reasons for its move, it should not be seen as encroaching into the domain of the State governments, which have the constitutional responsibility to maintain public order and exercise police powers. The BSF mainly focuses on preventing trans-border crimes, especially unauthorised entry into or exit from Indian territory. It does not have the power to investigate or prosecute offenders, but has to hand over those arrested and the contraband seized from them to the local police. In practice, BSF personnel usually work in close coordination with the police and there ought to be no clash of jurisdiction. It is possible to argue that the expanded jurisdiction merely authorises the BSF to conduct more searches and seizures, especially in cases in which the offenders manage to enter deep into the country's territory. However, it goes without saying that there ought to be strong reasons for the expansion of the jurisdiction of any central force. In this regard, the most relevant questions among those framed by the Supreme Court are whether the Centre's notification encroaches upon the State government's domain; and what factors ought to be taken into account while determining the "local limits of areas adjoining the borders of India".

AKING advantage of the distraction caused by the Ukraine war and the Israel-Hamas conflict, China has upped the ante in the South China Sea (SCS). The Philippines has accused China of deploying its mari-

time forces which have since February this year, "harassed, blocked and executed dangerous manoeuvres" against a resupply mission to the Second Thomas Shoal, a contested island hosting a small Philippines military contingent. Over several months, the Philippines coast guard has exposed the unlawful activities of China's coast guard and maritime militia.

China claims that the Scarborough Shoal and Second Thomas Shoal are in its maritime zone, while the Philippines claims these as part of its exclusive economic zone. In 2016, the International Permanent Court of Arbitration dismissed China's territorial claims against the Philippines under the UN Law of the Sea Convention. Beijing dismissed the ruling and continues to claim ownership and deploy various provocations. China has deployed its coast guard ships, and other boats masquerading as fishing boats, to patrol the busy waterway as if it were its territorial waters. Beijing claims "indisputable sovereignty" over almost all of the 3.5 million sq km of the SCS, as well as most of the islands and sandbars in it, including features that are hundreds of kilometres from the Chinese mainland.

China's coast guard ships have used water cannons against Philippine ships and even rammed into one of them. China has also used military-grade laser and acoustic devices against Philippine ships. The Philippines government had to summon the Chinese ambassador in Manila to lodge a protest, calling China's actions as a blatant violation of international law. Senior Philippine leaders have called for the expulsion of China's ambassador, who has been making aggressive 'wolf warrior' statements.


Philippine President Ferdinand Marcos Jr has said, "The aggression and provocations perpetrated by [China's maritime forces] have only further steeled our determination to defend and protect our nation's sovereignty, sovereign rights, and jurisdiction" in the SCS. This president has taken a more vocal and proactive stance against China as compared to the previous president, Rodrigo Duterte. The latter had tried to appease China and lost the election. The midterm elections in the Philippines are scheduled for 2025 and anti-China sentiments are

rising rapidly. The US has supported its ally and called on Beijing to desist from its dangerous and destabilising actions in the SCS. The US has said it stands by Manila and reaffirmed the 1951 Mutual Defence Treaty, which commits the US to help the Philippine armed forces if attacked.

China accused the Philippines of lying and claimed that Chinese ships had acted with professionalism and restraint, blaming the Philippine boats of "illegally intruding" into Chinese waters. China reiterated that its actions were a part of border control measures, as per national laws. China even claimed that a Philippine ship rammed a Chinese ship, though video evidence clearly

showed the reverse.

China's outlandish claim covers almost four-fifths of the SCS as its territorial waters and it has disputes over several islands in the SCS with several littoral countries. China wants to convert the SCS into a Chinese lake and wants other countries to fall in line with its dictates and abandon their own claims. It has built artificial islands too, militarised the illegally occupied islands to reinforce its claims, and attempted to enforce an air defence identification zone over the airspace. Deception and lying go hand in hand in China's pursuit of its foreign policy objectives. China's bullying tactics are designed to convey that it has overwhelming naval su-

periority and opposition is futile. China also wants the Philippines to eschew the option of granting the US access to its bases which are closest to Taiwan under the Philippines-USA expanded defence agreement.

Additionally, China wants to test the US's resolve in coming to the defence of its treaty allies. These tactics may expose American resolve and send a signal to its allies that the US is constrained. China's strategy has posed a new challenge to the US's strategy in Asia, but it has been careful in not crossing certain red lines. China has honed its 'gray zone tactics', which stay short of armed attacks. A collateral objective China hopes to achieve is linked to the supply chains moving out of China to the Philippines and other countries. China's grey zone warfare creates uncertainty for companies attempting to diversify supply chains out of China.

How to deter China-short of a full-blown conflict-is now the new policy dilemma for the US and its QUAD partners. This would require not just military deterrence but also a geoeconomic strategy. The summit between Presidents Biden and Xi at the APEC meeting in November indicated that China wants to run with the hares and hunt with the hounds. Under pressure of a slowing economy, vai lous sanctions on manufacturing of chips and the sudden purge of his foreign and defence ministers, Xi was conciliatory with the US; yet, Chinese forces bared their fangs in the SCS.

India has extended support to the Philippines and conducted maritime exercises with them. India's anti-submarine ship INS Kadmatt visited the Philippines in December; earlier, India had sold the high-tech naval version of the BRAHMOS missile to the Philippines. China is playing the long game, calibrating its aggression depending on the shifting ties between Beijing and Manila. China seeks to force the Philippines to abandon its claim to the Second Thomas Shoal. Kowtowing to China and accepting its dictates determines China's aggressiveness towards a neighbour.

The Philippines has decided to expose China's bullying to the world and ensure that China's fabricated narrative is debunked. Its more pugnacious stance signals that it will not submit meekly. The Philippines hopes to garner global support and set an example for other smaller nations to stand up to China. Among the QUAD countries, Australia, Japan and the US are shoring up support by capacity building and helping expose China's nefarious designs. (pr.chakravarty@gmail.com)

#### **VIKAS IN THE TIME OF 'AASTHA'**

## Whither Indian modernity?

Political landscapes are shfiting, and the growing identity divide challenges the universal values of modernity



n the 1950s and 1960s, discussions on developing country politics primarily revolved around tradition and modernity. Newly de-colonised societies were initially perceived as traditional, transitioning towards modernity. This modernity was expected to prize universal values of egalitarianism, identities that prize achievement over ascriptive values, and embracing the freedom of modern liberal democracy over the tyranny of traditions. In India, caste and religion were seen as impediments to this modernity, hindering political progress. However, later, there was a shift in understanding, arguing that traditional categories like caste were being mobilised for modern purposes within liberal democracy. The argument was, 'How else can liberal democracy be in India, if not in terms of caste?' However, the theorists of Indian democracy did not extend the same argument to religion because of the specific historical context of Indian democracy emerging amidst partition and communal bloodshed. Thus, the argument was that while it is caste that becomes the force of mobilisation, strengthening Indian democracy, religion, on the other hand, leads to communal politics. The terms of these arguments have, however, remained relatively constant, while, on the other hand, in India, religion has emerged as a difficult force to comprehend and contend with. The political landscape has evolved from a single-party democracy under the 'Congress system' to the single-party democracy of the 'BJP system' over the past decade. In the new system, it is not the universal identities of modernity that are aspired to but a narrow caste-less Hindu identity. The theorists advocating for democracy in terms of caste-based mobilisation now face the challenge of religion-based mobilisation, particularly in northern states where these identities are strong. Caste identities, once targeted for annihilation, have paradoxically strengthened due to decades of Lohiaite caste-based mobilisation by the political parties. The annihilation of caste did not happen. What took place because of caste politics was the strengthening of the identities of caste. Since these mobilisations were largely of castes within

the Hindu fold, eventual mobilisation by religion became easy. The mobilisation from the castes that were not in the Hindu fold often led to the backlash from the so-called upper and middle castes, which again strengthened, instead of diluting, the caste identities.

Governance and development have been ignored altogether in favour of caste mobilisation and caste-based resource distribution, notably in states like UP and Bihar, keeping identities within the traditional narrowness and bigotry. This scenario has facilitated the emergence of the BJP system, particularly in UP.



politics is surging ahead—both in terms of caste and religion—but the much-aspired universal egalitarian values are not developing.

The paradox is that economic improvement is not making us think in terms of secular values. Instead, economic development is progressing on the one hand, and de-secularisation is progressing on the other. What is the cause of this? The causes for this are to be found in the nature and character of the development process, which sidesteps and marginalises a large number of people, including the middle class, and favours the accumulation of capital in an ever smaller number of people. It is not economic development per se, but rather the nature and character of economic development that need to be examined for an understanding of the phenomenon of the rise of identity politics. In other words, the character of economic development and the nature of the development of identities and identity politics are interconnected. One cannot see them separately. Unequal economic development and gradual de-secularisation are connected realities. The greater the insecurity for ordinary people, the more and more they become de-secularised.

The slogan 'Aastha aur Vikas' should better be understood as identity politics because of the nature of economic development. Both of these are reinforcing. The more we are alienated and the more the circumstances appear to be insurmountable, certainly, the more we pray. This is 'Aastha' because of the socalled 'Vikas'. The early prognostications of the modernisation theory have proven wrong. We are increasingly de-secularized. All traditions are being re-invented by all sections. Today, we remember our ascriptive caste and religious identities more often than we aspire for universalist, egalitarian, and humanist identities. The blame for this rests squarely on the failure of modernisation in the country owing to the extremely unequal development process spearheaded by both the leading parties of the country: the Congress for a long time in the notso-distant past and the ruling BJP for a decade. The failure of modernisation is not, of course, new; many African and Latin American dictatorships have proven liberal modernisation theory earlier wrong. What makes this special in our case is that we were supposed to be an exceptional case in terms of our success in modernisation and liberal democracy! In the context of modernisation, there was an aspiration for the gradual secularisation of society. Religion was seen as gradually receding into the background as modernisation and modern economic development progressed. The current trend, however, indicates a reversal of secularisation, both in the public and private spheres. The early theorists hoped that in post-colonial societies, the secularisation process would gradually overcome religious and communal politics. That being the case, they hoped that being religious would become as optional as being atheistic. The trends that are blowing, however, are otherwise. The de-secularisation process is not only taking place gradually but is also being presented as the only option. Or de-secularisation ipso facto becomes the only option as the majority of the population finds themselves between the Scylla of identity politics and the Charybdis of neo-liberal economic development. This brings us to another point.

In modernisation theory, with the processes involved, it was hoped that as economic development progressed, other concerns, such as religious identity politics, would become secondary or be relegated to the past. On the contrary, the puzzle is this: as economic development progresses in India, identity

he presence of External Affairs Minister S Jaishankar at the 19th summit of the Non-Aligned Movement in Uganda attests to the fact that despite pouring scorn on the foreign policy of the country's first Prime Minister, the Modi government believes it is in its interests not to shake off this chapter of Jawaharlal Nehru's international legacy. NAM was powered by newly independent African and Asian nations that did not want to be aligned to either of the Cold War blocs. Nehru's stewardship of NAM, along with Egypt's Gamal Abdel Nasser and Yugoslavia's Josip Tito not only allowed India to punch above its weight in international politics but also gave India a global profile that did not need to be burnished at home or abroad with grand extravaganzas. In the last century, India, a rare democracy in the post-colonial world, was a natural leader of the under-developed and developing world, then known as the "Third World". Now, while Delhi stakes a claim to leadership of the "Global South", its aspiration is to sit at the international high table. In its attempts to balance between both, a so-called "relic" of the much-disparaged Nehruvian past is proving to be Delhi's best bet at pushing the idea of a multipolar world, in which it clearly hopes to be one of the poles.


In his remarks, Jaishankar made a pitch for "transforming" an inequitable world through "practical steps", and offered as an example India's own efforts on this front -- 600 projects in 78 nations, half of them in Africa, capacity-building through training, the sharing of Covid vaccines with 100

nations, and when natural disasters strike, "first responders to the developing world".

Interestingly, he projected India not as "Vishwaguru" but as "Vishwa Mitra", and instead of the claim to represent the voice of the Global South that Delhi repeated like a mantra all of 2023, the minister spoke about "drawing strength" from these countries.

Irrespective of these formulations, it is also true that India's ideological distance from NAM, or indeed the Global South, has never been more apparent. With the war in Gaza on top of everyone's mind, the Kampala Declaration was an all-out condemnation of Israel's "illegal military aggression" against "civilians, civilian objects", and of the "forced displacement of the Palestinian population", along with a call for an "immediate and durable ceasefire". It called for urgent steps toward ending Israeli occupation, and a two-state solution on the basis of the pre-1967 borders. In his own remarks at the summit, Jaishankar mentioned the war in Gaza, but made no mention of the appalling civilian casualties, nor of the Global South's unequivocal demand for a ceasefire as articulated in votes at the UN, though he said that "terrorism and hostage-taking are unacceptable". In the broadest of formulations, he reiterated India's position for a two-state solution. For the makers of "Bharat" then, NAM remains relevant, not so much for the positions it takes, but for its usefulness to Delhi to achieve its "strategic sweet spot".
