



Changes in NEET-UG 2024 syllabus

press note from Akash Byjus details the changes in the revamped NEET UG syllabus. The emphasis is on the collection of study materials for new topics, relying on trusted sources and both old and new NCERT books. Rigorous practice by solving ample questions, embracing experimental learning for comprehension, and maintaining the relevance of omitted topics within chapters are crucial strategies, says the press note. Here are the changes:

Physics

Class XII: Experimental Skills is the only new addition, with no deletions from the existing syllabus.

Class XI:Physical World has been removed, with no new topics included.

Chemistry

Class XII:Principles Related to Practical Chemistry is newly included, while The Solid State, Surface Chemistry, General Principles & Processes of Isolation of Elements, Polymers, and Chemistry in Everyday Life have been deleted.

Class XI: No new topic has been added, but States of Matter: Gases & Liquids, Hydrogen, The S-Block Elements, and Environmental Chemistry are no longer there in the syllabus.

Zoology

Class XII: No new topics but deletions include Reproduction in Organisms and Strategies for Enhancement in Food Production - Animal Husbandry.

Class XI:Structural Organisation in Animals - Animal Morphology (Frog) has been added, while Digestion and Absorption has been removed.

Botany

Class XII: Biodiversity and Conservation (Sacred Groves) is a new addition, while chapters such as Reproduction in Organisms, Strategies for Enhance-

ment in Food Production, and Environmental Issues have been excluded.

Class XI: Morphology of Flowering Plants (Malvaceae, Cruciferae, Leguminosae, Compositae, Gramineae) is a new inclusion, whereas Transport in Plants and Mineral Nutrition have been removed.

The changes were made in order to streamline the syllabus and make it more focused on core medical concepts. The excluded chapters are less relevant to medical practice. This will allow students to delve deep into crucial topics and improve their understanding. - DHNS

BU embeds software to detect plagiarism bug in PhD thesis

From November, the Bangalore University (BU) has deployed the DrillBit software, recommended by the University Grants Commission (UGC), to detect plagiarism in PhD thesis.

The university had deployed the anti-plagiarism software in 2015, but has switched to DrillBit for greater accuracy. Recently, the varsity's Baba Saheb Dr BR Ambedkar Central Library in partnership with the UGC and INFLIBNET held a regional training on the software for its faculty. More than 90 librarians, PhD guides and other faculty from varsities across Karnataka, Tamil Nadu and Andhra Pradesh participated in the training.



ian and coordinator for the programme, said that BU follows the UGC regulation (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) passed in 2018. Data from the university reveals that around 2,500 candidates are doing PhD and it awards more than 300 PhD degrees each year. While demand for PhD degrees in science subjects are the highest, the varsity also finds widespread interest in PhDs in management subjects.

Take up a job to get a feel of the corporate world

Dear sir,

I graduated with a bachelor's degree in civil engineering. I am confused about my future - whether to pursue MTech in Environmental engineering. I would like to know if the degree holds value in today's job market. Also, I am unaware of 'other' job opportunities or courses I can take as a graduate. Please help.

A confused soul

Dear student,

If you have not had any job experience, take up a job, at least for a short while, to get a feel of the corporate world. Do not jump into a Masters' course unless you are convinced you will pursue that field in the long run. There are opportunities in every field, but it depends on your abilities, personality traits, aptitude and abiding interest. List out all the possible options you have in terms of a long-term career. You can also look beyond civil engineering into many options, but you should base it on your capabilities and inclination. Nothing prevents you from getting into marketing, teaching, data analytics, design, management, or actuarial science - and, of course, Environmental Engineering. Even an internship in a small organisation working in the field you are interested in will get you a pretty good idea of whether you will fit into it. Then, you can think of upgrading your skills and qualifications accordingly.

Dear sir, Kindly educate me on how many (and which) languages are mandatory in each board until which standard. Also, what are the pros and cons of IB? We are a non-Kannada-speaking Bengaluru family. When I think about sending my kid to school, Kannada may act as a big boulder to cross. My mother used to oversee my homework and studies, and I intend to do so and not rely on tuition.

Dear Arvind,

It is good that you intend to teach your child personally rather than sending for tuition. It helps the child understand better and builds good child-parent bonding. Rules about different Boards of study, languages etc. should always be checked directly with the relevant authorities since they keep changing and may have different applications for different children. At a young age, children can pick up a language very fast if taught correctly and with compassion for the student's learning pace. Picking up Kannada at this age will help him in academics and communicating, interacting, and dealing with different types of people in Bengaluru and elsewhere. Do not worry whether it is a 'scoring' subject; focus on ensuring the child has good guidance and learning.

I pursued the science stream with PCMB subjects in Class 12 and got qualified for a marine engineering seat through KCET. But after my father's advice, I got into a BBM course. Now, I work as an Executive in an Ed-tech company. However, I am unhappy with my current career path. My heart lies in engineering. What are the possibilities for me to get into engineering after completing BBM?

Dear Wasiya,

Though you may find some universities that will accept you in engineering. you will be going back by four years. Since you are dissatisfied with your work, ensure that you will be happy and motivated if you take up engineering now and study for four more years. Evaluate on what basis you have chosen Mechatronics and how much you know about the field. As a BBM graduate, take up an entry-level job in an organisation connected to the Mechatronics industry and visualise how connected you feel. If yes, you can continue working and take up engineering in an evening college open to working professionals.

Early career counselling can help youngsters

Students can navigate their interests and abilities to develop an array of career options, with right guidance, writes Ankur Aggarwal



ften, with change comes a lot of confusion, anxiety, and anticipation of what will happen next; every growing child goes through this multiple times until they reach

adulthood. It becomes quintessential to guide, support and empower them to become responsible and successful as adults in the future.

Empowering can be fruitful through self-discovery and self-awareness, allowing the child to understand and accept their strengths and weaknesses. The biggest question is- what is that one element that will guide them to become responsible citizens and adults?

A student must know how to use the skills to fill in the gaps in various industries. A career coach will help them navigate their interests and abilities and, in turn, develop an array of career options that will empower them to work towards achieving their dreams.

Albert Einstein once said, "Everybody is a genius, but if you judge a fish by its ability to climb a tree, people will believe it is quite stupid. The fish's best ability is to swim in the water." The takeaway is that every student possesses a unique set of skills, and it takes a mentor or a coach to highlight that skill set in the concerned student.

A great philosopher, John Locke, talked about "Tabula Rasa", which means a child's mind is like an empty slate that observes data solely by sensory experiences. Therefore, early career guidance would help the students by filling their minds with the correct data

appropriate for a suitable career choice.

Going digital

The world is technologically evolving, and the career counselling space is becoming digitally advanced, too. From virtual workshops to AR-VR-driven courses, ample new experiences are lined up for the students to trigger their sensory points and allow them to take a deep dive into the world of new careers.

This is not only exciting for the kids, but it also provides parents with a space to discuss and gain knowledge from their kids about the ever-evolving landscape of new-age India. This helps bridge the gap between parents and kids and proliferates into a safe space for both parties to discuss previously unknown topics.

Finally, change is the new normal, and career counsellors must help students develop skills and adapt to change to survive and thrive in this competitive environment. Everyone wants to achieve their job goals, live a purposeful life, and like what they do, and career counselling serves as an excellent support platform for students on this journey.



TDK to make Li-ion battery cells for Apple

JAPAN'S TDK Corporation will manufacture Li-ion battery cells for Apple in its new plant in Haryana, said telecom and IT minister Ashwini Vaishnaw on Monday.

The minister, in a tweet also said the plant will create 8,000 to 10,000 jobs in the country. "Apple, via its global supplier TDK, will manufacture Li-ion battery cells in a new plant in Haryana. Will create 8,000-10,000 direct jobs. This state-ofthe-art plant will further deepen the component ecosystem in India," the minister tweeted. As per the reports, TDK acquired a 180-acre land near Gurugram, Haryana for ₹550 crore. The commercial production to supply cells to Apple is expected to begin in the next 12-18 months. TDK will supply battery cells to Apple's Li-ion battery assembler, Sunwoda Electronics, which is already operating in India and at present, imports cells from various global markets.


Key research hub leads global AI ethics debate

Pioneering scientist Yoshua Bengio warns companies about moving too fast on AI without guardrails

Rapid developments in artificial intelligence — and recent turmoil at industry powerhouse OpenAI — have brought fresh attention to a key hub of ethics research related to the technology. The hub is led by the Canadian 'godfather of AI', Yoshua Bengio, who says he is worried about technology leapfrogging human intelligence in the not-toodistant future.

Bengio — who won the 2018 Turing Award for work on deep learning with Geoffrey Hinton and Yann LeCun — warned that AI developments are moving at breakneck speed, and risked "creating a new species capable of making decisions that harm or even endanger humans".

OpenAI's recent dismissal and then rehiring a few days later of CEO Sam Altman



— who has been accused of downplaying risks in his pushtoadvance its ChatGPT bot — illustrates some of the turmoil in the sector. Bengio, who has previously warned companies about moving too fast without guardrails, reiterated that it's essential to have "rules that will be followed by all companies".

Al safety report

At a summit in Britain last month, Bengio was tasked with leading a team producing an inaugural report on AI safety. The aim is to set priorities to inform future work on the security of the technology. Accordingly, he has brought together a team of over a thousand researchers to his Mila research institute in Montreal, Canada.

Neighbours here include AI research facilities of tech giants Microsoft, Meta, IBM and Google. "This concentration of experts is greater than anywhere else in the world," is what attracted Google, says Hugo Larochelle, the hoodiewearing scientific director of the Silicon Valley giant's AI subsidiary Deepmind.

Back in 2018, consultations with the public and researchers from all disciplines led to a global AI charter called the 'Montreal Declaration for a Responsible Development of Artificial Intelligence'.

OpenAl's Q* is alarming for a different reason

WHEN NEWS STORIES emerged last week that OpenAI had been working on a new AI model called Q*(pronounced"q star"), some suggested this was a major step toward powerful, humanlike artificial intelligence that could one day go rogue. What's more certain: The hype around Q* has boosted excitement about the company's engineering prowess, just as it's steadying itself from a failed board coup. Peaks of AI excitement about milestones have taken the public for a ride plenty times before. The real warning we should take from Q* is the direction in which these systems are progressing. As they get better at reasoning, it will become more tempting to give such tools greater responsibilities. More than any concerns about AI annihilation, that alone should give us pause.

OpenAI hasn't confirmed what Q*is, with reinstated Chief Executive Officer Sam Altman only describing it as an "unfortunate leak," but in the media, it sounds similar to another system Alphabet Inc.'s Google is working on. Gemini is the big new competitor to ChatGPT, which won't only generate text and images but also excel at planning and strategising, according to Google DeepMind CEO Demis Hassabis. DeepMind famously created an AI model that beat champion Go players, and Gemini will use some of those techniques for problem solving.

With Q*, OpenAI seems to be pushing ChatGPT in a similar direction since, according to multiple reports, Q* can perform grade-school math. That might sound unim-

pressive, but combining math capabilities with software that can also write text and create imagery is unique, and ChatGPT until now has struggled to do equations correctly. If it could, that might correlate with an improvement in problem-solving. Math requires understanding a problem and figuring out the steps to solve it before carrying out all the right calculations. That process is a little closer to how we humans think and solve problems.

Early versions of Gemini can already execute some tasks that require planning, according to someone with access to Google's forthcoming tool who didn't want to be named due to confidentiality commitments.

Examples of tasks that Gemini can do are hard to come by, but the person who used the model said one could, for instance, ask it to conduct market research for a new product. It could then explore the web and come back with analysis and additional ideas. "With ChatGPT,

you still have to hold the hands of the model a bit more," they added.

As more AI systems are able to independently do things like conducting research, their human operators will likely shift from giving them single tasks, to giving them broader responsibility for several duties. Think coordinating with colleagues over email or managing analysis. That will sound tempting to any company eager to make itself more efficient, but such tools also promise to displace jobs, particularly entrylevel positions that ease young recruits into a new field. Companies that outsource more to AI also risk baking gender and racial stereotypes into their work systems. Most firms must choose from a handful of so-called foundation models from OpenAI, Google or Amazon.com Inc. to upgrade their infrastructure, and such models have been called out for not only showing entrenched bias toward people with disabilities and racial minorities but also for being highly inscrutable.OpenAI and, by extension, Microsoft Corp. have refused to disclose details that independent researchers need to determine how biased their language models are. Forrester Research Inc. has predicted that close to 7 million US knowledge workers will be using Microsoft 365 Copilot in 2024. Meanwhile, Google is rolling out its own competitor, Duet AI, to the more than 3 billion users of its enterprise platform Workspace.

As such tools are imbued with more planning and strategic skills, we'll talk much more about giving them "responsibility" instead of "tasks." But we should do so slowly and carefully. Their anticipated disruption could come back to haunt us.

Virtual RAM: More Storage or Gimmick?

Virtual RAM has now become ubiquitous in smartphones. After being present in PCs for years, the technology is being used by smartphone brands to make their products, especially in the entry-level and budget segments, more compelling to customers who treat the amount of RAM as a key factor in making the purchase decision. While most brands are restricted to offering as low as 3GB or 4GB RAM smartphones priced under in ₹10.000, adding another 4GB of virtual RAM - effectively marketing the product as having "4GB+4GB RAM" - gives an impression that the handset is more capable than before. But adding 4GB virtual RAM over 4GB physical RAM is not the same as having 8GB RAM in a mobile phone. At best, the marketing gimmick is good for keeping more apps running in the background, but has little impact in improving the overall performance of the phone or running heaving apps.

HOW DOES RAM WORK?

RAM, or random access memory, is a high-speed storage that stores data on a temporary basis, unlike the internal storage where data is stored permanently till its deleted or overwritten manually. RAM is called volatile memory because of its temporary nature, but is much faster than other types of memory such as hard drives.


WHAT IS VIRTUAL RAM?

Virtual RAM is a feature on some Android smartphones that uses a portion of the device's internal storage to temporarily act as additional RAM. It refers to RAM that is not physically present on your device, but is called to action when needed. Virtual RAM is called by different names by brands, such as RAM Plus (Samsung), Dynamic RAM Expansion (Realme), Memory Fusion (Tecno), RAM Expansion (Oppo) and simply Virtual RAM (Vivo). The technology, though, does the same thing: borrow memory from

internal storage to provide extra RAM when needed.

MEMORY MANAGEMENT ON ANDROID

Android works on the premise that free memory is wasted memory, and tries to use all of the available memory at all times, resulting in apps being stored in memory long after they have been closed by the user. Some, like the Facebo-

ok app, do not need refreshing when they are in the background, so they remain static in RAM. Some others, like Spotify, keep running even when the app is removed from the foreground, using RAM dynamically to scale up or down depending on the activity. These dynamic operations are de-

> legated to a partition in the memory which Google calls zRAM, where the app is com-

pressed so that it does not overload the phone.

HOW IS VIRTUAL RAM BENEFICIAL?

As budget smartphones already have less amount of RAM to work with (most come with 4GB RAM), virtual RAM is deployed by creating a zRAM partition out of the internal storage, so as to expand the memory capability in storing more of such dynamic apps. As a result, budget phones become more capable in running more apps on the device, especially those which get refreshed or updated in the background.

IS VIRTUAL RAM A GOOD THING? WHAT NO ONE WILL TELL YOU...

For one, using storage as RAM is not really beneficial as the natures of the 2 components are different. While RAM is non-volatile storage where any byte of memory can be accessed directly without having to read the preceding bytes, hard drives store data sequentially and must be read from the beginning to reach a specific location. Further, RAMs operate at much higher speeds as compared to storage memory. While this means virtual RAM may not work as fast as normal RAM, more importantly, it may reduce the life span of the internal storage as it is not meant for frequent read-write operations required to function as RAM.



Bengaluru has again topped the list in cybercrimes registered across all metro cities in India in 2022. The city has topped the chart of cybercrimes cases for several years now.

However, this time, the city accounts for nearly three-fourths of the cases recorded in 19 metro cities, as per the data released by the National Crime Records Bureau (NCRB) on Sunday.

The city reported 9,940 cybercrime cases of the 13,534 cases reported in 19 metro cities during 2022, or 73.4% of the cases registered, the data shows.

A senior official said Bengaluru tops the list in cybercrimes because of the high concentration of IT professionals in the city, which also reflects in high levels of awareness about cyber laws, prompting better reporting.

However, the NCRB data shows Hyderabad, the capital of Telangana, another

The city has also recorded the most narcotics cases among 19 metro cities across the country, with 4,027 cases, including 570 against peddlers in 2022.

The city police embarked on a special drive against narcotics in the city during the pandemic in 2020 and have kept at it since then.

The Police Commissioner releases data of drug seizures, cases and arrests made in narcotics cases every month.

The city also has the

IT hub in South India, reported only 282 cybercrime cases among the 19 metro cities. Lucknow, Ghaziabad, Noida, and Kanpur reported more cases.

The city, having five

most cases registered under The Immoral Traffic (Prevention) Act, 1956, essentially over prostitution. The city registered 403 cases, followed by Chennai which registered 156.

A senior official said that the high number of narcotics and prostitution cases was also an indication of better enforcement.

However, the city also saw the most dowry harassment cases. Of 1,221 dowry harassment cases registered in 2022, 964 were registered in Bengaluru alone. Patna in Bihar registered the second highest number of cases, 228.

With the growing number of cases, the City Police Commissioner had asked the jurisdictional law and order police to pitch in and start registering cybercrime related cases at the local police stations to assist their counterparts.

In addition the Commissioner has also set up five Special Investigation Teams (SIT) each headed by a Deputy Commissioner of Police (DCP) to probe specific kinds of cybercrimes.

Investigation and recovery of money lost in cybercrimes has improved with the Cybercrime Incident Report (CIR) which helps to freeze transactions of stolen money in cybercrimes in real time.

However, the recovery is still only a fraction of the money lost.

Information Technology Minister Priyank Kharge said that the State, on an average, lost ₹1 crore a day to cybercrimes in 2022.

Karnataka also topped the list of States in the number of cybercrime cases reported with 12,549 registered, out of the total 31,908 registered in 2022.

City also has most cases of rash and negligent driving

Bengaluru has also topped the chart in the maximum number of cases booked against drivers for rash and negligent driving, among 19 metro cities, in 2022, the National Crime Records Bureau (NRB) data released on Sunday showed.

The data revealed that a total of 2,111 cases were registered against motorists causing grievous hurt to a total of 2,428 people. Kochi comes second with 1,729 cases, ahead of Mumbai and Delhi.

A senior traffic police official said that the highest number of cases indicate better enforcement in the city rather than the driving scenario compared to other cities. However, he added a lack of lane discipline was a big problem.

The city traffic police have brought several mea-

sures to ensure discipline among motorists and to contain the number of road accidents.

However, owing to many reasons and the growing number of vehicles, limited road infrastructure, accidents and traffic violations are on the rise, the senior official said.




CHRONIC OBSTRUCTIVE PULMONARY DISEASE Don't ignore that wheezing during winters, it may worsen

HRONIC obstructive pulmonary disease (COPD) is a chronic inflammatory lung disease that causes obstruction to airflow to the lungs. Common symptoms include difficulty in breathing, coughing, wheezing and increased production of mucus. Being overweight affects body's response to Covid

Being overweight can impair the body's antibody response to SARS-CoV-2 infection but not to the protection offered by Covid-19 vaccination, according to a study published in the journal Clinical & Translational immunology, builds on the team's existing research on how Covid-19 affects people who are overweight. 

and FIND - a non-profit organization dedicated to improving diagnostic access - brought together state elected representatives, government



officials, experts, academia and civil society to discuss strategies to accelerate the elimination of cervical cancer in Karnataka.

As we develop a roadmap for eliminating cervical cancer, our first priority must be early and effective screening. While the current guidelines in India recommend visual inspection with acetic acid for women aged 30-65 years at least once every five years, WHO recommends screening women twice in their lifetime using high-performance HPV DNA-based tests, which are more effective in preventing cervical cancer than traditional Pap smears. Civil society organizations in Karnataka have already piloted these tests, with positive feedback and high acceptance of the tests including self-sampling by women.

Prevention is key in the fight against cervical cancer, but vaccination and screening programmes need to be scaled up nationally to ensure that all women in India have access to these lifesaving initiatives. India has demonstrated its ability to tackle and eradicate diseases before - the successful eradication of polio is a testament to our nation's commitment and capability. It is now time to channel this expertise towards combating cervical cancer and improving women's health, for a healthier and more empowered society.

EARLY SCREENING CAN SAVE YOUR BREAST

ITH advancements in treatment options, patients diagnosed with breast cancer in early stages need not fear about having to undergo mastectomy (surgery to remove a breast) as the breast can be preserved by only remov-

ing the affected area. New methods have also improved survival rates.

"Breast cancer is a curable disease. There is a need to get rid of the fear. If anyone notices changes in the breast whether - a painless lump, nipple discharge, discolouration in the skin, ulcer or wound that is not healing - they must immediately get it checked. The earlier it is diagnosed, the rate of survival and chances of conserving the breast is higher," said Dr Manjula Rao, consultant, breast oncoplastic surgery, Apollo Proton Cancer Centre, Chennai.

"Everyone from the age of 18 and above must perform monthly self-examination. Once a year, they should go and see a doctor. All women above 40 should get a mammogram once a year." she added.

Earlier, health experts viewed breast cancer as a localized disease that affects only the breast, but it has changed with the realisation that it is a systematic disease. It can spread to other organs like bones, liver, lungs and brain.

"Earlier, the treatment accompanied radical procedures in which doctors removed the entire breast and underlining muscle till the bone, as they thought the outcome will be better. It is not true, so the treatment also changed. Systemic treatment includes chemotherapy, targeted

therapy and hormonal therapy," said Dr K Keerthi, associate consultant, breast surgery, Kauvery Hospital, Chennai.

The need to transform agri-food systems

What did the report from the United Nations Food and Agriculture Organization say? How is favouring the cultivation of water-intensive cash crops like sugarcane and areca nut affecting the environment? How will diversification of crops help?

The story so far:

groundbreaking report from the United Nations Food and Agriculture Organization (FAO), published earlier this month, has laid bare the staggering hidden costs of our global agri-food systems, surpassing an astonishing \$10 trillion. In middle-income countries like India, these costs constitute nearly 11% of the GDP, which manifests as higher poverty, environmental harm, and health-related impacts, including undernourishment and unhealthy dietary patterns. The report blames "unsustainable business-as-usual activities and practices" for these escalating costs, pointing to a need to transform agri-food systems. One way to do so is to shift to multi-cropping systems that have the potential to protect farmers' well-being, improve nutritional outcomes for our communities, and positively impact ecological health.

What are the impacts of intensive agriculture?

Impressive improvements in agricultural productivity have been achieved in India over the last five decades by mainstreaming mono-cropping systems and chemical-intensive farming practices.

The Green Revolution focused on the marketing of high-yielding varieties of paddy and wheat on agricultural lands, which now constitute more than 70% of India's agricultural production. The infusion of seeds purchased from multinational corporations and fertilizers undermined seed sovereignty, dismantled Indigenous knowledge systems, and fuelled a shift from diverse crop varieties and staples such as pulses and millets to monoculture plantations. This trend also compromised the nutritional needs of households and resulted in adverse ecological consequences including excessive extraction of groundwater.

This privatisation and deregulation of agricultural inputs also increased indebtedness among agrarian households. In 2013, the debt to asset ratio of a farmer's household in India was 630% higher than in 1992. Agriculture in India has increasingly become unviable: the average monthly household income of a farming household sits at ₹10,816.

Which are the crops being favoured? Under the National Food Security Act 2013, 65% of households (around 800 million people) in India are legally assured a right to food at subsidised rates through the Public Distribution System and welfare programmes such as the Integrated Child Development Services and the Mid-Day Meal Scheme.

To meet this requirement, the procurement of food crops is coordinated by the Food Corporation of India (FCD, which is required to maintain a central pool of buffer stock and to procure, transport, and store foodgrain stocks in the country. However, this procurement policy heavily favours rice and wheat. In 2019-2020, the FCI procured 341.32 lakh million tonnes (MT) of wheat and 514.27 lakh MT of rice. Whole wheat and rice also became export commodities. In contrast, the Indian government approved the procurement of a total of only 3.49 lakh MT of coarse grains such as jowar, bajra, ragi, maize, and barley by State governments for the central pool and local distribution, which is less than 1% of total foodgrain procurement. Not surprisingly, the area under cultivation of

coarse grains dropped by 20% between 1966-1967 and 2017-2018, whereas the area under rice and wheat increased by nearly 20% and 56% respectively.

At the same time, other water-intensive cash crops like sugarcane and areca nut have also flourished under policies favouring investments in dams and canal irrigation (favourable for sugarcane) and free electricity for borewells (favourable for areca nut). This trend threatens food security and the production of nutritional crops. The expansion of sugarcane cultivation affects biodiversity, increases the pressure on groundwater resources, and contributes to air and water pollution. And ironically, small and marginal farmers in India are among the

most food and nutrition insecure. The global food system structure has a direct impact on the last mile - on both farmers and soil. Between 2012 and 2016, large fluctuations in soya prices in the global market and a glut in supply from Latin American countries eroded income for soy farmers and agro-companies in Malwa. Historically as well, global trade relations have influenced food production systems in the Global South. In the pre-independence era, tax systems were introduced to efficiently collect revenue for British-enforced exports of primary raw materials, such as cotton.

How can crop diversification help? A systemic shift in food regimes, from local to global value chains, is essential. The starting point for addressing these complex systemic issues could arise from local efforts, such as the diversification of farms

Diversified multi-cropping systems, rooted in agroecology principles, could be a viable solution to revitalise degraded land and soil. Practices known by various

names locally, like 'akkadi saalu' in Karnataka, involve intercropping with a combination of legumes, pulses, oilseeds, trees, shrubs, and livestock. This approach enables cash provision from commercial crops, food and fodder production, and offers ecosystem services such as nitrogen fixation and pest traps, and supports the local biodiversity. They also collectively contribute to improving soil health.

Critics have often argued against alternative farming systems, suggesting they may lead to a decline in farmer income even if the environment improves

But the FAO report says that there are substantial "hidden costs" associated with the current systems which need to be factored into long-term evaluations of income. Moreover, millets, whose yield per hectare is comparable to those of rice and wheat, are also more nutritious, grow in semi-arid conditions without burdening groundwater tables, require minimal input, and provide a diversified food basket.

While crop diversification will involve some loss of productivity using a narrow metric of kg/Ha, it would preserve natural capital and allow farmers to become nutritionally secure. By redirecting subsidies, currently accruing to corporations, we can pay farmers for their contribution to sustaining natural capital, instead of incentivising them to deplete it.

How can farmers transition?

It is unrealistic to expect farmers to shift away from mono-cultivation of rice and wheat overnight. This transition needs to be systematic, allowing farmers to adjust gradually. For instance, moving from chemical-intensive practices to

non-pesticide management, then adopting natural farming practices, can reduce input costs.

Farmers can diversify income through value addition, incorporating livestock and poultry. Some of these practices could be experimented with partially on specific portions of their lands.

Among the various transition pathways, a visual representation of a diversified farm involves allocating 70% for commercial crops, 20% for food and fodder, and 10% for environmental services like oilseeds (acting as trap crops). Over time, the fraction of commercial crops could be lowered to 50% and border crops could be replaced with locally suitable tree species for fruits and fodder. Integrating livestock rearing could further improve incomes. Some preliminary economic modelling of these pathways indicates the potential to improve ecological outcomes for the landscape and sustain farm incomes in the short run (up to three years) and the long run (up to 25 years).

However, addressing challenges related to local seeds, institutional arrangements for market access, drudgery, and the need for farm labour is crucial when envisioning such a transition.

Scaling up these practices requires collaboration among institutions, policymakers, and social groups to articulate economic incentives for farmers to shift from high-input monoculture to diversified cropping.

Govt lays out measures to contain black money menace in real estate

IN a bid to combat the circulation of unaccounted money or black money in the real estate sector, the government has implemented a series of stringent measures, ranging from legislative amendments to enforcement actions.

Under the provisions of the Income Tax Act, several key legislative amendments have been introduced, as per the written reply by Minister of State for Finance Pankaj Chaudhary to the parliamentary question.

Section 43CA and Section 50C of the Income Tax Act now require the adoption of the stamp duty value as consideration if it exceeds the declared amount. Section 50CA, along with relevant Income Tax Rules, mandates the use of the stamp duty value of immovable property to determine capital gains on the transfer of shares in unlisted companies.



tween the stamp duty value and the consideration received if it exceeds ₹50,000 in the hands of the recipient. Moreover, Section 194-IA now requires the deduction of 1% tax at the time of payment for any sum exceeding ₹50 lakhs as consideration for immovable properties. "In order to curb cash dealing in real estate transactions, section 269SS was amended to prohibit receipt of ₹20,000 or more for transfer of immovable property otherwise than by banking channel. Similar restriction is provided under section 269T," Chaudhary said. A similar restriction is imposed under Section 269T to enhance transparency. Specified entities are required to furnish a statement of financial transactions (SFT) for relevant transactions, including those related to property, as per Section 285BA. Rule 114B and Rule 114E of the Income tax Rules, 1962, mandate the mandatory quoting of PAN and reporting of immovable property transactions above specified thresholds.

Govt earned Rs 3.41L cr from taxes on petrol, diesel in 6 months

he government earned Rs 3.41 lakh crore from taxes on petroleum products, especially petrol and diesel, in the first six months of the current financial year, data released by the union petroleum ministry showed.

Out of this total tax collection, Rs 1.85 lakh crore went to the central government's kitty, while states collected Rs1.55 lakh crore, as per data provided by Minister of State for Petroleum and Natural Gas Rameswar Teli, in reply to a question in Rajya Sabha, on Monday. The minister stated that the cess on petroleum products, which is not shared with the states, increased to Rs 21,445 crore in 2022-23 from Rs10,676 crore in 2020-21. In the first six months of the current fiscal mop-up from cess stood at Rs 8,048 crore. "Lion's share of the taxes and duties are being collected by the central government. What is more perturbing is the exponential growth of



cess on the crude oil over the years, which doesn't form part of the divisible pool shared with the states," said John Brittas, Member of Parliament, Rajya Sabha, to whose query Teli had replied. Taxes imposed by the centre and the state governments form a major chunk of the price of petrol and diesel in India. The highest amount of tax is levied in the form of excise duty by the centre. States impose sales tax and value added tax (VAT) on top of it. During the financial year ending March 2023, the government earned Rs 7.48 lakh crore from taxes on petroleum products. Out of this, Rs 4.28 lakh crore went to the central government's exchequer, while Rs 3.20 lakh crore went to the states' kitty.

'Ending FAME subsidy will lead to 25% surge in EV prices'

FICCI seeks a 5-year FAME-III be rolled out as the ongoing scheme ends in March

Discontinuation of incentives offered under the Faster Adoption and Manufacturing of Electric Vehicles in India (FAME) programme will lead upto 25% surge in prices of electric vehicles in the country and may delay transition to cleaner energy, industry body FICCI said on Monday.

In a proposal submitted to the Union Ministry of Heavy Industries, FICCI has pitched for continuation of the FAME scheme for five years more. The second phase of the incentive programme (FAME-II) is set to come to an end in March 2024.

FAME scheme was launched in April 2015 with a capital outlay of Rs 895 crore to encourage faster adoption of electric and hybrid vehicles by way of offering upfront incentive on purchase of electric vehicles. The second phase of the scheme was launched in 2019 with a budgetary outlay of Rs 10,000 crore.

FAME-II was initially for a period of three years. It has been extended by one year till March end 2024. Recently the Department of Expenditure approved a proposal to increase outlay for FAME-II by Rs 1,500 crore taking the total outlay to Rs 11,500 crore.

"While we have well begun, we are nowhere close to being half done. Let us not forget that the current price premium of EV vis-à-vis ICE (internal combustion engine) without any subsidy is still



substantial ranging from 40% to as high as 130% for various segments," said Sulajja Firodia Motwani, Vice-Chairperson of Kinetic Engineering.

"Continuation of demand incentive or subsidy is imperative and critical to help reduce this price gap. Fame III is required to spur continued interest from customers in EVs and increase penetration over the next few years," she added.

In its proposal submitted to the ministry of heavy industries and NITI Aayog, FICCI has suggested that the third phase of FAME scheme should be implemented for five years with a provision of "mid-

In addition to supporting demand creation for the priority segments of public transport (eBus, E3W, e-taxi) and E2W (electric two-wheeler), FAME-III may also include segments like MHCV (trucks); personal segment for e4Ws and private buses, the industry body said.

"EV penetration in India is only 5% currently. It is imperative to continue FAME scheme to achieve critical mass towards reaching overall 30% EV penetration targets by 2030," FICCI said.

Nifty, Sensex touch new highs on key wins for the BJP

Both benchmarks logged their best session in 14 months


inancial and energy stocks led H shares to new all-time highs on Monday as key wins for the ruling party in state elections lifted the domestic market, already boosted by strong macroeconomic data and easing global interest rate expectations.

The NSE Nifty 50 index rose 2.07% to 20,686.80 points, notching a record high for second session in a row. The S&P BSE Sensex climbed 2.05% to 68,865.12, a record close. Both the benchmarks logged their

best session in 14 months and settled in the over-bought zone.

India's ruling Bharatiya Janata Party (BJP) secured key victories in three of the four state assembly elections, results showed over the weekend.

"The party in Indian equity markets will go on," said Gaurav Dua, senior vice president and head of capital market strategy at Sharekhan by BNP Paribas.



"The strong macroeconomic data, favourable political outcome from state assembly elections and improving global environment has moved sentiment to risk-on from risk-off," Dua added.

Dua expects a further 5%-8% rally in the benchmark Nifty 50 between

now and Lok Sabha elections in May 2024. Eleven of the 13 major sectors hit new all-time highs on Monday. Financial services rose up 3.23% and energy stocks climbed 2.61%, leading sectoral gains. The two indexes account for about 46.5% weightage in Nifty 50 index.

Index heavyweights Reliance Industries, ICICI Bank, HDFC Bank gained between 1% and 5%.

The Nifty had hit a record high on Friday, on the back of strong quarterly growth and monthly factory activity data.

Larsen & Toubro jumped 3.93% after several analysts identified the company as one of their preferred picks, citing potential gains from the government's focus on infrastructure and welfare spending.

Adani group stocks advanced between 1.4% and 10% and topped gains in several sectoral indexes including metals and energy.

Tech capital's cyber-savy citizens turn capital for fraudsters

At 10,000, Bengaluru saw most cybercrimes than any other city: NCRB

he tech-savvy netizens of Bengaluru were preyed on the most by cybercriminals as the city reported 9,940 cases of cybercrimes in 2022, according to the 'Crime in India 2022' report released by the National Crime Records Bureau (NCRB) on Sunday.

According to a senior police officer, cybercrimes currently comprise 28% of the total cases in the city.

The cases in Bengaluru with an estimated population of 85 lakh as per the 2011 census were more than the combined total reported by Mumbai (4,724) and Hyderabad (4,436) ranked second and third, respectively, the annual report revealed.

An analysis of the NCRB data revealed a 54.75% increase in cybercrimes in 2022


compared to 2021 - showing a worrying trend in the Silicon Valley of India.

In 2020, Bengaluru reported 8,892 cybercrime cases. In 2021, there was a 27.76% decrease as 6,423 were reported, but it rose significantly in 2022 as the total stood at 9,940. The charge sheet rate was at 22.6, the data showed.

Fraud main motive

The report revealed that the motive in 93.45% of the cases was to defraud, followed by extortion (364), sexual exploitation (224), causing disrepute (26), personal revenge (20), emotional motives like anger (12) and others (5).

Around 9,501 cases in 2022 were of computer-related offences, including 6,319 cases of cheating by personation using computer resources. Data showed that 422 cases were related to the publication or

the transmission of obscene or sexually explicit acts in electronic form.

Interestingly, the city reported zero cases of online banking fraud, OTP fraud, data theft and cyberstalking or bullying of women and children in 2022.

More netizens, more cybercrimes

State CID chief Dr M A Saleem said that the propensity for cybercrimes was higher in Bengaluru as the population of the 'net citizens' was more and there was an increased dependency on online financial transactions.

"Because of the sheer number, the vulnerability is also high," Dr Saleem, Director General of Police (DGP), Criminal Investigation Department (CID), Special Units and Economic Offences, told DH. "Greed is also a key factor in many cases. Physical crimes like robbery, dacoity and house break-in thefts and chain snatching cases are coming down - giving way for digital

crimes."

The city has eight separate police stations dedicated only to cybercrimes and a main cybercrime station, the first in the country to be set up in 2001, at the CID building.

"All police stations are empowered to take up cybercrime cases," Dr Saleem said.

"We are also training the station house officers (SHOs) of all the law and order police stations regarding the inves-

Sensex rises 1,384 pts to new high in bull charge

Nifty50 also takes wing to reach fresh high



he Indian equity benchmarks soared to unprecedented heights on Monday. The catalysts were the recent state election results, which further built hopes among investors of continuity of government at the Centre after the Lok Sabha polls next year.

The bulls, already invigorated by the prospect of imminent rate cuts by the US Federal Reserve, bought shares across the board, propelling the combined market cap of all BSE-listed firms by ₹5.8 trillion. The Sensex climbed 1,384 points (a 2.05 per cent increase) to close the session at 68,865; the Nifty50 rose by 419 points (a 2.1 per cent gain) to end at 20,687. For both indices, this marked the most significant single-day gain in nearly 14 months. Moreover, the Sensex and the Nifty50 reached fresh highs on both intraday and closing bases. The Bharatiya Janata Party (BJP) emerged victorious in three state elections by retaining Madhya Pradesh and wresting Chhattisgarh and Rajasthan from the Congress. The BJP's performance surpassed expectations, as the elections were widely

considered a close fight in three states.

The election results assuaged investor concerns about whether a poor showing by the ruling party would heighten the risk of more fiscal populism. "The equity market looks at how money is being spent effectively, and the sustainability by way of policymaking," said A Balasubramanian, managing director & CEO, Aditya Birla Sun Life AMC. "The market reaction is a clear endorsement of growth and not driven by freebies." He further said: "The valuation picture is not concerning as long as the cost of capital does not rise, the interest rate trend remains the same, and there is no doubt on the growth outlook of India." The surge in the market capitalisation of all listed stocks on the BSE marked the highest one-day gain since May 17, 2022, when the stateowned Life Insurance Corporation (LIC) was listed. Pranav Haridasan, MD & CEO, Axis Securities, said: "The assembly election results have thrown a positive surprise for the markets, with the markets now assigning a greater probability of continuation of existing government policies beyond 2024." Indian companies should invest in 'climate vulnerable' nations: Nasheed

More Indian companies ought to be investing in clean energy projects in Maldives and other 'climate vulnerable' countries instead of putting money in "iron and steel" as this would be a "good investment", former Maldives President Mohamed Nasheed told *The Hindu* on Monday.

Currently, the Secretary-General, Climate Vulnerable Forum (CVF) - a grouping of 58 countries

that are particularly vulnerable to natural disasters from climate change - Mr. Nasheed said India's commitment to installing 500 GW of electricity from nonfossil fuel sources and reducing emissions by 45% suggested that "it was on track" as far meeting its commitments to the Paris Agreement was concerned. The 2015 agreement, to which India is a signatory, seeks to cap global average temperature rise below 2°C and "as far as possible" below 1.5°C. "More than taking on emis-

sion cuts, India should be investing more in renewable energy projects in climate-vulnerable countries," said Mr. Nasheed.

Mr. Nasheed said that he had seen interest from "several Indian investors" in investing in renewable energy projects, particularly solar and wind projects, in countries that are part of the grouping.

Development banks and richer developed countries could play an important role in "de-risking investments", he said while stressing that the vulnerable countries were not really asking for grants but seeking real investments in their economies.

Sensex, Nifty climb 2%, scale new peaks after poll results

BJP's victory in three States lifts sentiment as investors bet on stability post 2024 general elections; ICICI, State Bank of India lead gains in the Sensex, while 44 of the Nifty's 50 stocks post advances

he Sensex and Nifty rose more than 2% to close at record highs on Monday, marking the fifth straight day of gains as the BJP's poll victory in three States boosted investor sentiment.

The 30-share BSE Sensex jumped 1,383.93 points, or 2.05%, to close at a lifetime high of 68,865.12. The benchmark logged its biggest single-day jump since May 20, 2022.

The broader Nifty also climbed 2.07% to an all-

time closing high of 20,686.80. Analysts said BJP's clear majority in Madhya Pradesh, Rajasthan and Chhattisgarh State polls strengthened the positive sentiment built up last week following robust macroeconomic numbers and unabated foreign fund inflows. Oil prices hovering below \$80/barrel also lifted sentiment.

ICICI Bank and SBI led the Sensex higher with gains of 4.68% and 3.99%, respectively. Other gainers included Larsen & Toubro and HDFC Bank.

The BJP's landslide win in three States "spurred a rally with an anticipation that the country will witness a stable government post the general elections next year," said Vinod Nair, Head of Research at Geojit Financial Services.

RPL case: SAT nixes SEBI's order against RIL's Ambani

The Securities Appellate Tribunal (SAT) on Monday set aside the penalty imposed by SEBI on Reliance Industries' Chairman Mukesh Ambani and two other entities in a case related to alleged manipulative trading in the shares of erstwhile Reliance Petroleum Ltd. (RPL) in 2007.

In January 2021, SEBI imposed fines including a ₹25 crore fine on RIL and ₹15 crore on Mr. Ambani.

GST appeals pile up as new filings near 3,000 till October

Pending taxpayer appeals over central GST levies have risen by as much as 25% through the first seven months of this financial year, with almost 3,000 new appeals being filed since April, the Finance Ministry informed Parliament on Monday, acknowledging that such appeals have risen significantly in recent times.

As per data shared with the Lok Sabha, the number of taxpayer appeals pending under the GST regime,



have actually seen a higher uptick over the first half of this year than all of fiscal 2022-23, when about 2,100 appeals were added to the pending cases list.

The number of pending appeals over central GST levies stood at 14,897 as of October 31, compared with about 11,899 on March 31. More than 2,300 of these appeals were filed between April and June and about 660 appeals were filed in the four-month period between July and October.

While the ministry reiterated the Centre's decision to constitute State Benches of the muchawaited GST Appellate Tribunals, as per the recommendations of the GST Council, it did not give an explicit response to members' queries about the anticipated timeline for their operationalisation.

"It was nice to get out there with the guys and have some fun," Woods said.



Surva comes out of shadows

young and fearless Indian team checked most of the boxes in the 4-1 series triumph over Australia. Barca's loan star Felix makes Atletico pay

Joao Felix's superb dinked finish earned Barcelona a vital 1-0 win over Atletico Madrid on Sunday in the LaLiga title race.

The Portuguese forward, on loan at Barca from Atletico, made no secret of his pleasure to escape the Spanish capital this summer and made his parent club pay at the Olympic Stadium.

Felix was criticised by some Atletico players ahead of the game and Barca coach Xavi Hernandez called on him to use those words as inspiration, which he duly did.

The forward's goal allowed Barca to reclaim third place from Atletico, now trailing leader Real Madrid and second place Girona by four points.

Atletico has not won away against the champion in LaLiga since 2006, a run

Editorial

A dark shadow on New Delhi's credibility

n the shadowy world of espionage, intelligence and covert operations, the only rule is to never get caught carrying out a mission. In the more visible world of public diplomacy, the only rule is to never get caught telling a lie or denying what might turn out to be true. The recent publication of a United States Department of Justice indictment against an Indian national for targeting wanted Khalistani separatists in North America, at the behest of a government official who may or may not have been acting alone, is as yet an unproven allegation that must stand trial, but is one that has nonetheless cast a dark shadow on New Delhi's credibility in terms of both covert capacity and public messaging, which must be addressed.

Other operations in the limelight

The indictment also comes on the heels of a number of intelligence operations that have been challenged in courts in other friendly countries in recent years: from the forcible return of a United Arab Emirates princess, Latifah, by the Indian Coast Guard in international waters in 2018 that has been criticised by a court in the United Kingdom, to the "attempted kidnap" of businessman-on-the-run Mehul Choksi from Antigua to Dominica by British nationals alleged to have been working for Indian agencies in 2021, and the conviction of eight former Indian naval officers in Qatar for espionage, which is now in appeal. While the extra-judicial military court trial against former Indian naval officer Kulbhushan Jadhav in Pakistan since 2016 has been challenged by India at the International Court of Justice (ICJ), the fact that he was operating his business from Iran, a friendly neighbour, has no doubt been noted. Meanwhile, the circulation of a list of alleged operations against wanted Khalistani and Pakistani operatives not just in Pakistan but also in Nepal, Italy, the United Kingdom and Thailand, has been hailed in the media as proof of the Indian security establishment's global reach. It must be remembered that the government has so far not accepted that it ordered any of these operations, but is not averse to the larger narrative that security agencies have been "empowered" to carry them out.

It is in this context that the government must engage with the troubling questions thrown up by the latest allegations – by the U.S. of a conspiracy to murder Gurpatwant Singh Pannun in New York, that also indicates a link to the murder of Hardeep Singh Nijjar in Canada, and the direct allegation by Canada, made by its Prime Minister Justin Trudeau on the Nijjar killing. To begin with, the text of the American indictment unravels two conspiracies – one carried out by the Indian who has been indicted, Nikhil Gupta, who was allegedly directed by a senior government intelligence official, and the other carried out by

the Federal Bureau of Investigation and Drug Enforcement Administration, to entrap him by providing an undercover officer to him as the hitman. The fact that the U.S. government did not share all that it knew with India questions the claims made otherwise that the two countries have, between them, reached the pinnacle of security cooperation this year. To not have shared them even when Mr. Trudeau made his statement in Parliament might have spared New Delhi the blushes when the details of the U.S. indictment were published. Instead, despite two meetings between U.S. President Joe Biden and Prime Minister Narendra Modi, four between Minister of External Affairs S. Jaishankar and U.S. Secretary of State Antony Blinken, and several between National Security Adviser (NSA) Ajit Doval and his U.S. counterpart NSA Jake Sullivan, as well as Central Intelligence Agency (CIA) and Intelligence chiefs, the U.S. appears to have cautioned India, but not revealed the full extent of information it had gathered.

Trust is still an issue

For the U.S., it is also obvious that it does not trust the information India has shared on Mr. Pannun, Nijjar and the Khalistani separatist movement, and hence is more focused on the plot against them than it is on curbing their activities. For India, given India's deep concerns with Mr. Pannun's radical rhetoric, even broadcasting a threat against Air India flights, and threats to diplomats and embassies, the U.S.'s actions are a breach of trust.

The actions hark back to the nature of intelligence sharing in 2008, when the U.S. warned India about the impending 26/11 terror threat (November 2008 Mumbai attacks), but did not divulge that the source of the information was Lashkar-e-Taiba operative David Coleman Headley, who even re-entered India with another diabolical plan in 2009. After the U.S. arrested Headley, it entered a plea bargain, that meant the man who decided the targets and planned the attacks to precision could never be brought to justice in India, and the government was forced to take his testimony via video-camera for the trial.

What this indicates is that while bilateral ties and strategic ties are growing in different spheres, trust between both countries has not kept apace. While much commentary is focused in the short term on whether Mr. Biden will confirm his attendance at the Republic Day parade and the Quad summit (Australia, India, Japan and U.S.) in January, it is the impact on the longer arc of the relationship that both sides must focus on.

By extension, South Block must also look at the impact of its actions among western allies including the "Five Eyes" intelligence partnership (Australia, Canada, New Zealand, the U.K. and the U.S.). By rejecting Canadian allegations outright,

expelling diplomats and suspending visas, while accepting the U.S.'s allegations more calmly and setting up a high-level inquiry to investigate them, New Delhi has demonstrated a double standard in its international engagements. The difference between India's reactions to Khalistani protests, and the attempted firebombing of the San Francisco consulate, to protests in the U.K., Australia and Canada is also stark: while their envoys have been summoned and Mr. Modi has publicly raised the Khalistan issue and protection of Indian-origin minorities with their leaders, the government has been more discreet in its concerns with the U.S. Conversely, there is a well-recorded double standard from the West when it comes to extra-judicial covert operations and assassinations - the CIA, MI6 and Mossad have often eliminated those they see as a threat on foreign shores, while sanctioning Russia for the Skripal attacks, Saudi Arabia for the Khashoggi killing, and publicly shaming India over the alleged claims on Mr. Pannun and Nijjar, and all Five Eye nations including New Zealand have issued statements criticising India for its actions against Canada. While such double standards are as old as time, it is significant that they have not been whittled down by the significant strengthening of the India-U.S. relationship, billed as the "most consequential partnership of the century".

Impact on the neighbourhood

Further afield, India must address the impact of the case on the neighbourhood. Countries such as Sri Lanka and Bangladesh stood with India on the Canada issue, but as details of the U.S. indictment are revealed, South Asian capitals, and not just Islamabad, will be studying the footprint of Indian agencies in their countries as well. South Block and its embassies in the neighbourhood will have to go the extra mile to assure the neighbours, especially in Kathmandu, Dhaka, Male and Colombo, where reports about India's "hand" in domestic politics is often discussed in exaggerated tones.


Eventually, the lasting impact of the episode will lie in the image India wishes to project to the world – as a "hard power" that is willing to risk international ire and ties in pursuing those it considers a threat in any corner of the world in any manner it deems fit. Or that of an adherent to international law that builds its case through its diplomats, turning global opinion in its favour to achieve its ends, albeit at the risk of being seen as a "soft power". The Ministry of External Affairs has said categorically that covert, extra-judicial assassinations are not this government's policy and that the allegations will be investigated. A deeper investigation would reveal whether India's actions align with its values and interests.

CLIMATE JUSTICE IS A MUST, BUT SO IS MEETING GREEN TARGETS

N the day Narendra Modi chastised the Global North for hypocrisy at COP28, India's national weather forecaster predicted a warmer winter ahead. This November has already been declared the warmest since 1901. It was a cold reminder of sorts for a country that has been made to bleed by extreme climatic events. So the prime minister's call for action based on climate justice, equality and shared responsibility was spot on. He said: "A small section of mankind has exploited nature indiscriminately. But the whole of humanity is paying its price, especially the residents of the Global South. This thinking of 'only my welfare' will take the world towards darkness." India's historical share in global carbon emissions over a century and a half is about 3.21 percent. In contrast, the UK's share in cumulative global emissions is 4.5 percent while the US accounts for over 29 percent.

There is little doubt that climate action must be a global effort, rather than developed nations adopting the position of high priests and leaving the developing countries to pay for their aspirations. After Russia's war in Ukraine started, rich countries were quick to fall back on coal and oil-based energy despite commitments to the contrary. Another marker of their double standards is the \$100-billion Green Climate Fund, which has failed to take off, as Modi pointed out in Dubai. Set up in 2009, it was to be funded by developed nations for helping developing nations move more towards renewable energy. India's requirements necessitate the use of coal-fired energy to meet its development demands. The country plans to invest over ₹80,000 crore over the next five years to increase coal production to meet the demands of the world's largest population. But it needs to adopt caution at the same time. Climate change's impact on the economically-weaker sections and on infrastructure will only grow sharply if corrective measures are not taken in time. Adopting technology for reducing carbon emissions and doubling down on renewable energy commitments must take priority. Although India skipped the pledge by 110 nations to triple the global renewable energy installed capacity by 2030, it must not lose sight of its own target. India has taken a leadership position in the Global South and must ensure that it walks the talk-but without compromising on national interests.



ರಚಿಸಬೇಕು ಎಂದು ಹೇಳುತ್ತದೆ. ಈ ಸಮಿತಿಯು ಸಮೀಕ್ಷೆ ಕೈಗೊಂಡು, ಬೀದಿಬದಿ ವ್ಯಾಪಾರಿಗಳನ್ನು ಗುರುತಿಸುವ ಕೆಲಸ ಮಾಡಬೇಕು. ಬೀದಿಬದಿ ವ್ಯಾಪಾರಿಗಳ ಸಂಖ್ಯೆಯು ವಾರ್ಡ್, ಪಟ್ಟಣ ಅಥವಾ ನಗರದ ಒಟ್ಟು ಜನಸಂಖ್ಯೆಯ ಶೇಕಡ 2.5ರಷ್ಟಕ್ಕಿಂತ ಹೆಚ್ಚಿರಬಾರದು ಎಂದು ಕಾಯ್ದೆ ಹೇಳುತ್ತದೆ. ವಲಯವೊಂದರಲ್ಲಿ ನಿಗದಿತ ಪ್ರಮಾಣಕ್ಕಿಂತ ಹೆಚ್ಚಿನ ಸಂಖ್ಯೆಯಲ್ಲಿ ಬೀದಿಬದಿ ವ್ಯಾಪಾರಿಗಳು ಇದ್ದರೆ, ಸಮಿತಿಯು ಹೆಚ್ಚುವರಿ ಬೀದಿಬದಿ ವ್ಯಾಪಾರಿಗಳಿಗೆ ಲಾಟರಿ ಮೂಲಕ ಅಕ್ಕಪಕ್ಕದ ವಲಯಗಳಲ್ಲಿ ನೆಲೆ ಕಲ್ಪಿಸಿಕೊಡಬೇಕು. ಸಮೀಕ್ಷೆಯು ಪೂರ್ಣಗೊಳ್ಳುವ ಮೊದಲು ಯಾರನ್ನೂ ತೆರವು ಮಾಡುವಂತೆ ಇಲ್ಲ. ಒಮ್ಮೆ ಸಮೀಕ್ಷೆ ನಡೆದ ನಂತರದಲ್ಲಿ, ಕನಿಷ್ಠ ಐದು ವರ್ಷಕ್ಕೆ ಒಮ್ಮೆಯಾದರೂ ಸಮೀಕ್ಷೆ ನಡೆಸಬೇಕು. ಸಮಿತಿಯು ಕೈಗೊಂಡ ತೀರ್ಮಾನವು ಯಾರಿಗಾದರೂ ತೃಪ್ತಿ ತರದಿದ್ದಲ್ಲಿ, ಅದಕ್ಕೆ ಮೇಲ್ಮನವಿ ಸಲ್ಲಿಸುವ ವ್ಯವಸ್ಥೆಯ ಬಗ್ಗೆ ಕೂಡ ಕಾಯ್ದೆಯು ಹೇಳಿದೆ. ಮೇಲ್ಮನವಿ ಸಲ್ಲಿಸಿದ ವ್ಯಕ್ತಿಯ ವಾದವನ್ನು ಆಲಿಸದೆ, ಆತನ ಅರ್ಜಿಯನ್ನು ಇತ್ಯರ್ಥಪಡಿಸಲು ಅವಕಾಶವಿಲ್ಲ. ಬೀದಿಬದಿ ವ್ಯಾಪಾರಿಗಳು ಮತ್ತು ಇತರರು ಸಾರ್ವಜನಿಕ ಸ್ಥಳಗಳನ್ನು ಒತ್ತುವರಿ ಮಾಡಿಕೊಳ್ಳುವುದು ಒಂದು ಪಿಡುಗು, ಇದು ಪಾದಚಾರಿಗಳನ್ನು ತೊಂದರೆಗೆ ಸಿಲುಕಿಸುತ್ತದೆ ಎಂಬುದು ನಿಜ. ಆದರೆ ಬಿಬಿಎಂಪಿ ಕೈಗೊಂಡಿರುವ ಕ್ರಮವು ಕಾಯ್ದೆಯ ಆಶಯಗಳಿಗೆ ವಿರುದ್ಧವಾಗಿರುವುದಷ್ಟೇ ಅಲ್ಲದೆ, ಮನಸೋಇಚ್ಛೆ ವರ್ತನೆಗೆ ಸಮನಾಗಿದೆ. ಈ ಕ್ರಮಕ್ಕೆ ವಿರೋಧಗಳು ಬಂದಾಗ ಅಭಿಯಾನಕ್ಕೆ ತಾತ್ಕಾಲಿಕ ತಡೆ ಬೀಳುತ್ತದೆ. ಆದರೆ ಇಷ್ಟೇ ಸಾಕಾಗುವುದಿಲ್ಲ. ಕಾಯ್ದೆಯನ್ನು ಸಂಪೂರ್ಣವಾಗಿ ಅನುಷ್ಠಾನಕ್ಕೆ ತರಬೇಕು. ಬೀದಿಬದಿ ವ್ಯಾಪಾರಿಗಳು ಮತ್ತು ಹಾಕರ್ಗಳು ಸಮಾಜದ ದುರ್ಬಲ ವರ್ಗಕ್ಕೆ ಸೇರಿದವರು. ಅವರಿಗೆ ಕೂಡ ಜೀವನೋಪಾಯ ಕಂಡುಕೊಳ್ಳುವ ಹಕ್ಕು ಇದೆ.

ನಾಮಾಜಿಕ ಸ್ವಾಸ್ಥ್ಯ ಉತ್ತಮವಾಗಿ ಇರಬೇಕು ಎಂದರೆ ಅಲ್ಲಿ ಶಾಂತಿ, ಸುವ್ಯವಸ್ಥೆ, ಸಾಮರಸ್ಯ, ಸೌಹಾರ್ದ, ಸಹಬಾಳ್ವೆಯಂಥ ಮೌಲ್ಯಗಳು ಪರಿಣಾಮಕಾರಿಯಾಗಿ ನೆಲೆಗೊಳ್ಳಬೇಕು. ಜನರು ಪರಸ್ಪರ ಪ್ರೀತಿ, ವಿಶ್ವಾಸ, ಬಾಂಧವ್ಯದ ವಾತಾವರಣದಲ್ಲಿ ಬದುಕಬೇಕು. ವ್ಯವಸ್ಥೆ ಸರಿದಾರಿಯಲ್ಲಿ ಸಾಗಲು ಈ ಅಂಶಗಳೇ ಪೂರಕ. ಆದರೆ, ಇತ್ತೀಚಿನ ವರ್ಷಗಳಲ್ಲಿ ಇದಕ್ಕೆ ತದ್ವಿರುದ್ಧವಾದ ಬೆಳವಣಿಗೆಗಳು ಸಂಭವಿಸುತ್ತಿದ್ದು, ಹಿಂಸಾಚಾರ ಹೆಚ್ಚುತ್ತಿದೆ. ಹೊಸ ಬಗೆಯ ಅಪರಾಧಗಳು ತಲೆಎತ್ತಿವೆ. ಕ್ಷುಲ್ಲಕ ಕಾರಣಕ್ಕೂ ಗಂಭೀರ ಅಪರಾಧಗಳು ಘಟಿಸುತ್ತಿದ್ದು, ಮನುಷ್ಯನ ಜೀವಕ್ಕೆ ಬೆಲೆಯೇ ಇಲ್ಲದಂತಾಗಿದೆ. ಸೈಬರ್ ಅಪರಾಧದ ಲೋಕವಂತೂ ಇನ್ನಷ್ಟು ಕರಾಳ. ಬಿಗಿಯಾದ ಕಾನೂನು, ಬಲಗೊಳ್ಳುತ್ತಿರುವ ಪೊಲೀಸ್ ಹಾಗೂ ಗುಪ್ತಚರ ಪಡೆ ಸೇರಿ ಸಂಬಂಧಿತ ಇಲಾಖೆಗಳು, ವಿಭಾಗಗಳು ಕೆಲಸದ ವ್ಯಾಪ್ತಿಯನ್ನು ಹೆಚ್ಚಿಸಿಕೊಂಡಿದ್ದರೂ, ಅಹಿತಕರ ಘಟನೆಗಳ ಸಂಖ್ಯೆ ಏರಿಕೆ ಆಗುತ್ತಿದೆ. ಇದು ಅಪಾಯಕಾರಿ ಮನೋವೃತ್ತಿ. ಇದನ್ನು ತಡೆಯಲು ಸರ್ಕಾರ ಮತ್ತು ನಾಗರಿಕ ಸಮಾಜದ ಸಾಮೂಹಿಕ ಪ್ರಯತ್ನ ಅತ್ಯಗತ್ಯವಾಗಿದೆ.
